## MEETING MINUTES

The regular meeting of the VCOI was called to order at 8:31PM Jan. 20, 1988 by President Roy Greffin. Secretary Gwen Tomlinson read the minutes from the previous meeting. Tony Lucas motioned, Linda Busch seconded to accept the minutes as read. Passed by voice vote. Treasurer Iris Pechota gave the financial report. She reminded us of some big bird expenses coming up. Bird costs, etc. were discussed. Hunting Test Chairperson Ann Lucas reported, first correcting two items in the newsletter - it was Tony's step-father (not Uncle) who passed away, and the AKC did not refuse our date for the Hunting Test, it was our choice not to hold the test on that date. Roy Greffin is looking into getting a date for a test in the fall at DesPlaines. Tony Dewar suggested we combine with another club. Discussion followed. Tony Lucas motioned to table the topic until a later date. Tony Dewar seconded but added that we should not forget it. Passed by voice vote.

Randy Boggs, Fun Trial Chairperson, said that the Spring Fun Trial will be Sunday, Feb. 21, 1988 at 8:00AM at DesPlaines Wildlife Area, West Grounds. Randy suggested everyone bring a lunch and plan to spend the day. There will be a puppy seminar for novice dogs and handlers, plus our usual stakes. There will be a \$5 per entry fee to cover bird costs. Spring Field Trial Chairperson Bill Elliot said we have approval for March 5 & 6, 1988 at DesPlaines West Grounds. Randy Boggs and Tony Lucas are judging puppy and derby, Geno Woehrle and Tom Gaulke will judge the Gun Dog stakes, and the Limited Stakes are retrieving. Open Limited will be open to other breeds, and there will not be a limit on entries. Dinner will be on the grounds Saturday night. Arrangements for all day horse rental must be made with the wrangler (ph. 414-889-8380). Someone is needed to pick up the birds before the Trial.

Tony Dewar volunteered to chair the Fall Trial if someone will be secretary. Tony Lucas motioned that we sell the Weimaraner club 50 of the birds we have reserved. Seconded by Tony Dewar. Passed by a voice vote. Tony Lucas announced that the Weimaraner Club is having a Field Trial the weekend after ours, with all stakes except Puppy open. Also that weekend is the Amateur Invitational (Sunday).

Kathy Harmer, Trophy Chairperson, reminded us that trophy donations for the July specialty show are due the first part of March. Picnic arrangements were discussed. Tony Lucas motioned, Tony Dewar seconded, that we solicit donations to cover the costs of lunch at the Specialty. Passed by voice vote.

Geno Woehrle, head of the Nominating Committee, named the Directors whose terms have expired; Bob Heise, Tony Ordonez, and George Peirce. Remaining are Rose Crago and Tony Lucas. Roy Greffin is retiring as President and will go to the Board of Directors. The new slate of Officers is: Randy Boggs, President, Harry Ruffner - Vice-President, Gwen Tomlinson - Secretary, Iris Pechota, Treasurer. Board of Directors: Roy Greffin, Kathy Karmer, Bill Elliott, and Geno Woehrle. No nominations were made from the floor. Linda Busch motioned, seconded by Cheryl Woehrle, to elect the Nominating Committee's slate of Officers. Passed by voice vote. Roy Greffin passed the gavel to new President Randy Boggs.

Gwen Tomlinson announced that there is a nice write up about our own Ken Crago in the January AKC Gazette and brought a copy for all to see. Iris Pechota volunteered refreshments for the next meeting. Bill Elliot motioned, Ann Lucas seconded, to adjourn the meeting. Passed by voice vote. Meeting adjourned at 10:00PM. ## HEARTWORM REMINDER!!!

Spring is just around the corner and with it, the threat of heartworm. Heartworms are parasites which live in a dog's circulatory system and heart, and can cause serious illness and even death. Transmitted by mosquitos, heartworm has reached epidemic proportion in Illinois.

Fortunately, there is a relatively easy way to protect your pet from heartworm. There are several preventatives on the market available from your veterinarian in the form of a daily or monthly pill. It is advised to start the treatment well in advance of the mosquito season, but it is important to have your dog's blood TESTED for the presence of heartworms BEFORE BEGINNING THE PREVENTATIVE.

Stone City Kennel Club will be sponsoring a Heartworm Testing clinic on March 30th starting at 6:30, Veterinarians will be Wayne Ingvide, DVM and Dale Ritter, DVM. Fee of \$6.00 per dog.

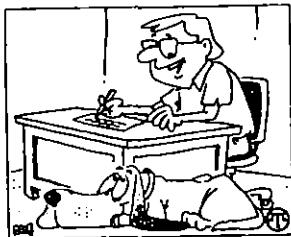
The column below has been sent out to newspapers across the country by the American Kennel Club as part of their effort to educate the public regarding "vicious dog" legislation (as opposed to breed-specific laws). This has been a hot topic of late in many cities, including my own, and it will most likely continue to grow. We, as responsible pet owners need to take the time to find out about this topic, form an opinion and then let that opinion be known through letters to law-makers, visits to public hearings, etc. Poorly written vicious dog legislation CAN affect us - consider the fact that one city has a law so vague as to ban "short-haired dogs between 30 and 120 pounds"! The AKC Gazette has printed several articles in its regular column "Legislation and the Law" on this subject.



## **DOG Facts & Fancies**

### **Dog Owners Sending Letters to Legislators**

Many dog owners are taking time to write their local leaders to ask for vicious dog control legislation that doesn't discriminate by breed. Many believe that if a law can discriminate against one breed of dog, one day it may be their own pet that's threatened.



**Many dog owners are writing local leaders to ask for non-discriminatory vicious dog control laws.**

The American Kennel Club (AKC) is an active supporter of strong vicious dog control legislation. However, the AKC believes that declaring an entire breed vicious and passing special laws won't solve the problem. They believe it's better to give specific substantial penalties for irresponsible owners of vicious dogs and to educate the public on responsible dog ownership. Dog care experts point out that the reason dogs get vicious is due more to mistreatment by their owners rather than the breed of dog.



The Rio Salado Vizsla Club officers, board members and members are appalled by the article "Getting Hip to HD" written by Mary Warzecha and published in the February, 1988, issue of Dog Fancy. The Vizsla certainly does not have a reputation for being a dysplastic breed. Of course there are dysplastic Vizslas, but if your author would do some more homework on the subject of HD, she would find that there are MANY other Sporting breeds that have a much higher incidence of hip dysplasia.

We especially object to having been singled out by Ms. Warzecha, as The Vizsla Club of America and all of the local breed clubs have been doing so much to try to breed out hip dysplasia in our breed. We have been praised and complimented for our efforts and other breed clubs have set up similar programs. NO dog may be advertised or listed in the Stud Dog Listing of The Vizsla News unless he has an OFA number. This information must be documented. Also, in each issue of The Vizsla News, there is a list of Vizslas, males and females, that recently have gotten OFA numbers and a complete list of Vizslas that have been certified over the years is available from the Vizsla Breed Improvement Committee chairman. The OFA sends a list of certified dogs directly to the National club. An interested buyer does not have to guess if the puppy that he is considering has HD parent, grandparents...and so on. The facts are available for him to research.

If Ms. Warzecha would check out a list on hip dysplasia in breeds, we are sure that she would find that the Vizsla is not among the top breeds as stated.

You certainly do owe us an apology, and it would behoove you to print some kind of clarification statement in Dog Fancy as soon as possible.

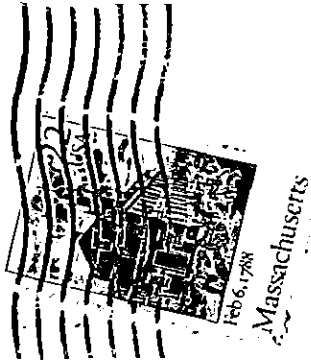
