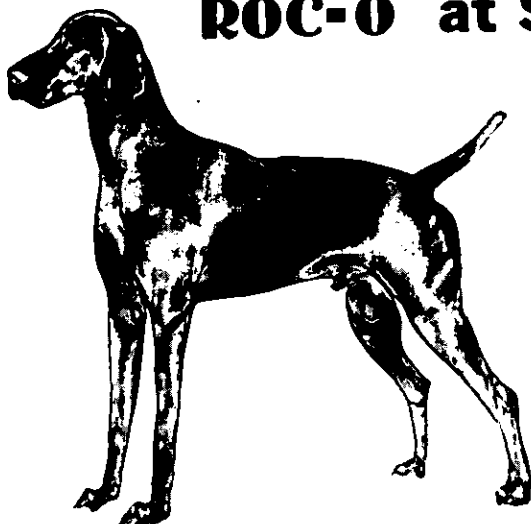

## UNDERSTANDING GASTRIC TORSION,

Anyone who has been around dogs for even a little time can recall the sight of a puppy with a swollen stomach. This swelling may be caused by worms, but more often, it's from overeating, and is cause for little alarm. But when this "gastric dilatation" or bloat suddenly occurs in certain breeds of adult dogs, a veterinarian should be consulted immediately for it often precedes gastric torsion.

Acute dilatation and gastric torsion refer to consecutive stages in the torsion process; dilatation is the stomach bloating with gases, while torsion is a twisting within the abdomen. Puppies can suffer the bloating, but the torsion usually occurs only in adult dogs. For purposes of this article then gastric torsion exists when the dog's stomach swells with accompanying rotation.

Although it is an extremely serious condition, gastric torsion is relatively rare. In a meeting last year of the American Animal Hospital Association in San Francisco, most small animal practitioners surveyed mentioned treating no more than one or two cases a year.

### WHAT DOGS ARE AFFECTED

Gastric torsion occurs most frequently in the larger deep-chested breeds, particularly Great Danes, St. Bernards, Germ. Shep., and Doberman Pinschers. However, a few cases involving smaller dogs have been reported. The torsion syndrome occurs in both male & female dogs. The dilatation or abdominal swelling begins suddenly and usually within six hours after excessive eating or drinking. The symptoms vary from vomiting and labored breathing in less severely affected dogs, to suffocation and shock in the more serious cases. The pulse weakens and the temperature may rise to 103° F. Unless quickly diagnosed and treated, the animal may die within 36 hours.

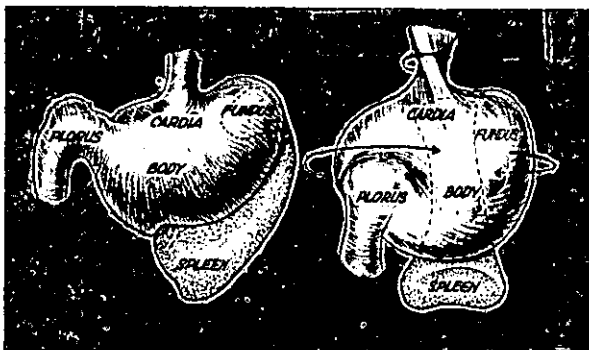

### CAUSES

The causes of gastric torsion are not clearly understood. Heredity has been suggested as a factor, particularly in cases involving Bloodhounds. Most authorities agree that the swelling usually occurs in hot weather, after the dog has consumed great quantities of food or water. Often, vigorous exercise preceded or followed the meal. As the stomach becomes overloaded with food and the surrounding muscles and linings weaken, a rapid abdominal enlargement occurs. This is the gastric bloat or dilatation phase. During this period,

the animal may be reluctant to move or lie down and often stands with mouth open and forelegs apart.

While most canine authorities agree that the torsion occurs with a pendular rotation of the stomach, the actual mechanism and dynamics are still perplexing. The torsion may result from an abrupt twisting of the body, probably through exercise, or the stomach itself may rotate in relation to the body.

Another possible explanation is that the enlarged spleen acts as a pendulum swinging the stomach out of its position. In one case then, it is the stomach that rotates and causes the spleen to fold and congest. In the other, it is the pendular rotation of the spleen twisting the stomach.

The direction of the torsion depends upon the position of the spleen at the onset of swelling. A 270° clockwise or a 90° counter-clockwise rotation of the stomach has been recognized. This twisting causes the stomach and splenic blood vessels to constrict. The remote portion of the spleen then folds upon itself causing severe congestion, stoppage of blood flow and shock.

### TREATMENT

Veterinarians treat these patients as emergencies. If the use of a stomach tube does not bring relief, immediate surgery is required. Surgery may be extensive, and in steps, to prevent over stressing the already desperately ill patient. The surgery consists of a gastrotomy which frees food materials and gases. The stomach must then be reattached with sutures to the abdominal wall to prevent recurrence. Following the operation, a six-hour period of intensive care with the administration of antibiotics and intravenous fluids may be needed. The veterinarians will usually recommend that solid food be withheld for the first 12 hours, with normal food resuming in about two weeks. His recommendations should be followed explicitly.

### COMPLICATIONS

There are many factors which complicate the already serious nature of the illness. Of crucial importance is the time variable, for unless diagnosed early and properly treated, the dog will probably die within 36 hours. Secondly, a major surgical operation may be performed involving vital internal organs. This is the reason for the first step being minor surgery to relieve distension, while major surgery attempts to correct the torsion. The animal is often in a severe state of shock and unable to respond to normal treatments. Finally, unless the proper preventive measures are used, gastric torsion has a high probability of recurring.

### PREVENTION

While there is much controversy as to the causes of gastric torsion, canine authorities agree on good management practices as the best preventive. Torsion does not occur suddenly after one overindulgence, but is possibly due to improper feeding over a prolonged period. Often for months prior to the actual torsion, the dog will have recurrent swelling and excessive gas. These authorities recommend that small quantities of food and water be given each (4-5 times per day or free choice). Vigorous exercise immediately before or after a heavy meal is forbidden.

Most importantly dogs are like human beings and require the same common sense and moderation we do. Do not overfeed your pet. Obesity leads to inactivity, contributing to ill health from many diseases.

# 60-Second Field Dress

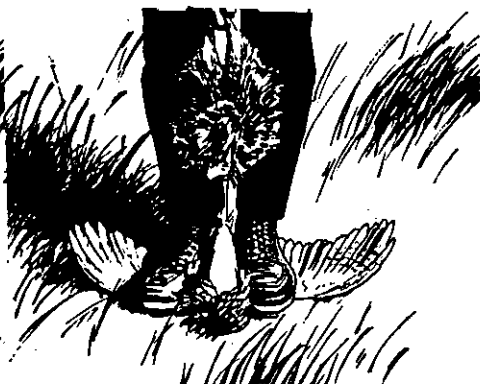

Dressing game birds is nobody's favorite part of the hunt. Here is a quick method that will minimize this formerly unsavory task. In less than 60 seconds you can field dress most any upland game bird so that when you return to camp or home at the end of a long day the job will already be behind you. This simple, quick-as-a-flash method has been tested on pheasant, ruffed, spruce and sharp-tail grouse and Hungarian partridge, and there is no reason why it should not work on light and soft-skinned upland birds. Try it. You'll like it.

Place both feet firmly on birds wings, next to body. With both of birds feet in one hand, extend body to full length in preparation for a strong pull.



Begin pulling legs upward in a firm, even motion. Legs, body feathers, insides and head will pull through and away from the body.



Bird is now in two sections. Wings and breasts are attached and clean. It's the law in some areas to leave wings on during transportation.



Push skin back from legs and pull off. Sever thigh at the body and cut off leg. The finished product: a cleaned bird in less than a minute, ready to go.

RECEIPE OF THE MONTH: PHEASANT LOS BANOS-STYLE  
(submitted by Gloria Ingrassia of Saratoga, Calif.)

1 wild or domestic pheasant, about 2½ lbs.  
1/2 tsp. each marjoram, thyme, and summer savory or 1-1/2 tsp. fines herbs  
1 cup sherry  
1/4 cup flour  
1 tsp. seasoned salt  
1/4 tsp. pepper  
1/2 to 1 cup water  
1 cup sour cream  
1/4 to 1/2 cup toasted sliced almonds  
Long grain and wild rice pilaff

Wash pheasant and cut into pcs. Cut breast in two and then cut each breast half into two pcs. (Cutting up pheasant is very much like cutting up a chicken except the bones are much "tougher", especially with game birds. Pheasant breast is considered the choice part, so cut it into enough pieces so each person can have a share). If bird is very fat, pull and cut off excess. Arrange pieces in a glass bowl or baking pan. Sprinkle on crushed herbs and pour on sherry. Marinate all day, or overnight in refrigerator, turning occasionally. An hour or two before serving time, lift out pieces and pat dry with paper towels. Combine flour with seasoned salt and pepper and dip pheasant pieces into flour mixture. If bird is fat brown pieces in drippings from pheasant fat. Otherwise, heat a tablespoon or two of oil and brown floured pheasant pieces. Arrange pieces in heavy casserole. Pour off and discard all but 3 tablespoon fat remaining in skillet. Add any remaining seasoned flour to the drippings. Add 1/2 cup water to the sherry marinade, pour into skillet, and heat, stirring, until simmering. Pour over pheasant; cover and bake at 350° for 30 to 40 minutes or until tender. (If you wish to prepare the pheasant earlier, set the oven at 300° and bake for 1-1/2 hrs or until tender) At serving time, lift out pheasant and keep hot.

Stir sour cream into the sauce in the casserole, adding 1/2 cup hot water if you prefer a thinner sauce. Return the pheasant to the sauce and sprinkle with toasted sliced almonds. Keep hot in oven until serving time. Serve with a long grain-wild rice pilaf. Serves 4.

A really deluxe way of cooking small game birds such as quail, pheasant, doves, or grouse is to use vine leaves. Rub the cleaned birds inside out with a little salt and fill them with celer stuffing, then wrap each bird in 2 large vine leaves and pack four of them in a glass baking dish with a tight-fitting cover. Then cream ½ pound of butter with 1 tbl. of flour, season it with salt and pepper and pack this around the birds. Cook, tightly covered, for about 40 mins. at 400°.

Also for squab or cornish hen.

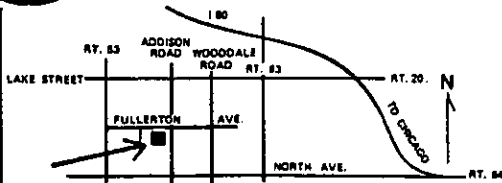
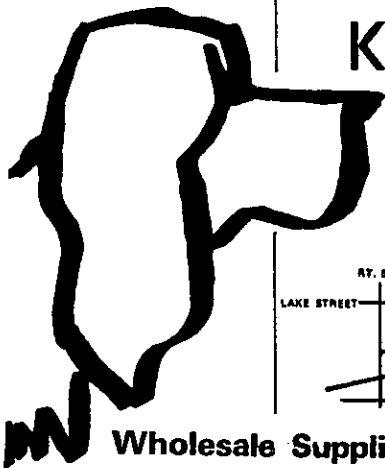
