Heartworm

Many dogs innocently fall victim to canine heartworm disease. If not detected and treated, the disease can lead to extensive organ damage and death to dogs. Warn the American Veterinary Medical Association and the American Heartworm Society.

The disease is caused by long white worms called *Dirofilaria immitis*. Canine heartworm disease can reach advanced stages and even cause death before signs become apparent to the owner. In its early stages heartworm disease can be detected using a blood test. Sometimes an infected dog will have adult worms but none of the tiny *microfilariae* in the blood. To confirm the infection in these cases, a veterinarian must use X-rays, repeated blood examination or other laboratory tests.

Canine heartworm disease is transmitted by mosquitoes. When biting an infected dog a mosquito may take up blood containing immature stages of the heartworm. After a two-week incubation period in the mosquito, they develop into infective larvae. If these larvae are transmitted by the mosquito to another dog, they migrate through the body to the heart. Here they grow to adult size of from six to fourteen inches in length in about five to six months.

Heartworm disease in North America until recently occurred primarily along the Eastern Seaboard and Gulf State regions. The American Heartworm Society now reports the disease has spread to almost all mosquito-infested areas of the United States, and is now found in every state east of the Rocky Mountains, and several cases have been diagnosed in the Pacific Coast region.

Most affected dogs can be treated successfully, the AVMA points out, if the disease is diagnosed in time. Drugs are available that will kill the adult worms. There is always some risk involved in treating a dog for heartworms; veterinarians caution, but fatal reactions rarely occur among dogs that are otherwise in good health. Complete rest is necessary after treatment to avoid lung damage from dead and decomposing worms.

In areas where the disease is or may be a problem, the American Heartworm Society recommends testing of dogs during the spring of the year. A veterinarian can then prescribe a sound preventive program or treat the dog if heartworm disease is found.

Interdigital Cysts

All dogs, whether large or small, appear to be subject to foot trouble. Although dogs are not generally believed to sweat from the surface of the skin, they have numerous sweat glands between the toes. The orifices of these may become blocked from other causes such as mild dermatitis. As a result the gland becomes choked with a mixture of sweat and sebaceous material, giving rise to what is known as an interdigital cyst. The trouble may be confined to one cyst between a pair of adjoining toes, or there may be more than one cyst.

Generally speaking, cysts are confined to forefeet but occasionally one may encounter a cyst in a hind foot. The cyst holds the two adjoining toes apart, thus causing pressure upon the cyst wall, which can be very painful. A dog which develops one interdigital cyst will usually develop more than one, often several in fairly quick succession. The dog spends a great deal of time licking the cyst without result. If a cyst does not receive early attention it is likely to become infected and terminate in an abscess.

In the case in which one solitary cyst appears, becomes very sore and develops into an abscess, a search should be made to make sure that the cyst does not contain a grass seed. Occasionally, one of these will bore through the sweat gland and up under the skin at the foot to produce an abscess in the region of the pastern.

Thanks to Betty Solberg & Helen Malicek who have consistently submitted good articles for us to enter each time in our Bulletin.

The usual treatment for an interdigital cyst is to open the swelling and squeeze out the contents. After this the toes are spread apart by inserting a pad of cotton wool between each pair of toes and follow this with a bandage covering the whole foot but not applied too tightly. This is left on for two days and then removed.

The veterinary surgeon will probably administer some antibiotics and possibly include a corticosteroid. This treatment usually cures the cyst in question but does not prevent others developing, usually on the opposite foot. We have obtained good results by removing the sweat gland entirely and suturing the toes together at the site of the operation down about a third of their length. This usually prevents any repetition of the cyst formation between that particular pair of toes.

Dogs which show a tendency to develop one or more cysts between the toes should have their feet soaked for ten minutes daily in a solution of a tablespoonful of salt and a tablespo-

ful of alum in a pint of lukewarm water. This hardens the feet and probably lessens the amount of sweat secreted. This is also a good treatment for what one may term "sloppy" feet and weak pasterns, especially when coupled with daily road work.

Another condition fairly common, especially in brindle-coloured dogs is a dermatitis of the skin covering the joints of the toes. The dog licks the feet to overcome the itching and promptly removes any dressing applied. These cases improve when the feet are soaked daily in the salt and alum solution, and after one or two applications the toes should be thoroughly dried and then painted over with collodion which protects the skin surface. Failing this, one may try painting the toes with gentian violet.

Another condition met with sometimes in the foot region is associated with an infection between the nails of the feet and the circle of skin surrounding the base of the nail. This can be due to a fungus infection, not unlike "athletes' foot" in humans, but not due to precisely the same fungus.

In other cases loss of nails may arise from a thyroid deficiency and the veterinary surgeon will prescribe a suitable endocrine. The nails may be painted daily or less frequently with gentian violet.—(From "Canine Casebook"—England's "Our Dogs")

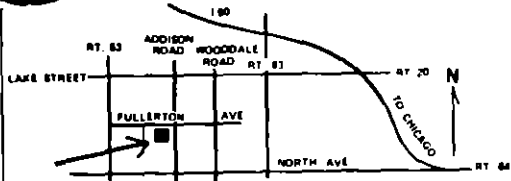
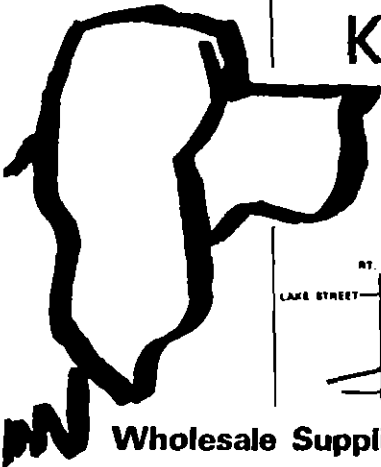

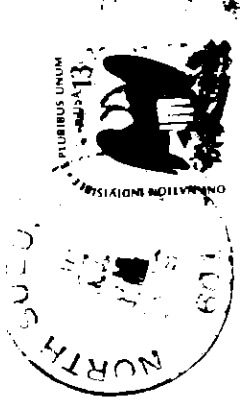
