The act of preparing these top ten field lists is a bit like watching time lapse photography. As you read through the placements in the Gazette and make the entries on each dogs record, the efforts of a whole month get squashed into a few hours. All the "might have beens" and "should haves" get trimmed away and "what I's" gets left behind. This November Gazette has the results of seven trials in which Vizsla's placed. If I had known what transpired at those seven trials when I made my predictions I might have included Tecumseh Fox and Yankee as part of my picks. I didn't though.

In the open Championship, of the five dogs I picked, two made the eight dog second series. Brooks Willie Whompum and Cody's Dark Star. Of those two, Cody's Dark Star went on to win the championship. That is not really great crystal ball work, considering that Dark Star has been at the top of the Top Ten for several years now. If Yankee had been one of my picks that would have been great picking. Assuming all goes well both of these dogs are shoo-in picks for next year.

Fox came back from a Spring of non-competition (at least non-placing) to leap into the national spot light with a second placement in the National Championship in a row. That is a very nice accomplishment. I wonder how successful the dog could be if the money were spent to give it a real shot at the top.

Timmy was one of my picks for the Amateur Championship. He came within 10 feet of grabbing a big piece of the Amateur i.e. Tim stopped 10 feet short of Paul with the bird in a call back for retrieve. As the only amateur handled (and trained) Vizslas to place in the open in the last two years. His placement is a terrific addition to his First Place in the 1981 National Amateur Championship.

In the Amateur Championship, I again picked five and again only one of my picks came through. In addition to Tim, others came close but close is not good enough. Ten year old Brooks Willie Whompum grabbed second place to save me from total failure. Willie at ten years of age made many of the youngsters in this stake look like they were on a slow boat to China. Anyone who watched the brace of Willie (10½ years) and Timmy (8 years) had to have been covered with Goose Bumps. What HEART!!

I picked one of Boggs' dogs to place in this one but I picked the wrong one. The older one (7 years) came through.

John Frayne also brought 2 entries to the Amateur Championship. The Father (8 years old) won the ribbon for him. John trains his own dogs, competes out East with Burjan, Seelye and Smith. He has to be good to stick and survive in that arena. He takes his share and more of the placements with plenty of homework and handling acumen. John brought all of these skills with him to Michigan and took home a piece of the Amateur.

You know how it is. When you're in a stake, the person you most want to win is yourself. However, if you yourself can't win there are some you'd like to see win and some you hope never win. Well, Gene Remmer and Rikki Knoh won the Amateur and the crowd went wild. Not one person there begrudged Gene that championship. Genes' wife was there as she always is. They exchanged hugs and kisses with each other. They had tears of happiness in their eyes as did many in the crowd. It was neat.

Usually a dog that is trained by a pro and handled by the pro, does not do well when turned over to the amateur owner to be run. The dog that is trained and handled by his amateur owner almost always will come out on top. Rikki is not your usual Vizsla and Gene is not your usual amateur owner. Four years ago I gunned the Amateur Championship Bird Field in Illinois. Gene and Rikki placed that year in spite of the fact that Gene did everything in his power to make the dog break. Rikki was 4 then-he is 8 now. Rikki is still a well broke almost flawless performer. Gene has become an excellent handler and fitting partner for his dog. The championship could not have happened to a nicer team.

PUPPY TESTS

These are mainly used in picking dogs for the handicapped.

1. **Auditory** The trainer stays about six feet away from the dog or puppy and makes a sound. These include a harmonica, a whistle, jingling keys, an alarm clock, a smoke alarm and a tape recorded siren. The other trainer watches and records the responses: excellent if it is alert to the sound and goes directly to the source, good if alert and faces the direction of the sound, fair if alert but fearful and poor if there is no response.

2. **Temperament** This consists of tolerance to pain, submission to trainer, suspension and reaction to a startling occurrence. In the pain tolerance test, a hair is pulled from the rump of the dog. If the dog feels this but does not object, the verdict is excellent. If it shows timidity, good; no response, fair; snapping or biting, poor. Submission consists of the trainer putting an arm around the dog's neck and forcing it to lie down. If this is accomplished without a struggle, excellent; a slight struggle and then submission, good; continually struggling or snapping and biting, fair to poor. In the suspension test, the trainer places a hand, palm side up, and arm under the dog so it is straddling the arm with its head resting on the palm of the trainer's hand. If it does not fight this or struggles a few seconds and stops, the rating is excellent to good. Continued struggle or biting is fair to poor. Reaction to a startling occurrence is induced in grown dogs when the trainer suddenly opens an umbrella as the dog walks by. With a puppy, the trainer makes a series of quick, jerky movements. If the dog is startled but recovers quickly and is curious, or if startled and recovers quickly, rating is excellent to good. Timidity or aggression scores fair to poor.

3. **Willingness to work** Natural retrieving ability is the criteria here. The trainer throws an object, a ball, stick, crumpled newspaper or a stuffed toy about six feet in front of a dog or three feet from a puppy. If the dog retrieves the object and returns it with or without encouragement, it is rated excellent. If it goes to the object and picks it up, good; fair, if it picks up the object and runs away from the trainer; poor if no interest is shown.

4. **Curiosity/Intelligence** A mirror is placed three feet in front of the dog. If it goes to the mirror and looks, excellent; if it sees the mirror but does not go to it, good. The rating is fair to poor if the dog is afraid or aggressive and poor if there is no response. Other tests in this category include a wind-up toy and a piece of paper or plastic which is pulled over the ground on a five-foot string. The ratings are the same here: excellent if the dog investigates the moving objects and follows them, good if it goes to them, fair to poor if aggressiveness, fear or no response are the reactions.

In the derby I picked 5 dogs plus 3 extra. Of the eight, two did not attend the Nationals. The judges gave four placements and one Honorable Mention. Four of these five placements went to my picks. First, Second, Third and the Honorable Mention. Rocket, a long range Vizsla, disappeared in the heavy cover and Kelly Donham who was handling him was unable to get him to the bird field. If Kelly & Don (Rocket's owner) had known the cover was so heavy, I doubt if they would have brought him. J.R. and Bill Boyd got braced with Chauncy Smith. They both use the same kind of whistle and their technique is very similar. I think it took J. R. too long to figure out who to listen to and then it was too late. Askim, Best Bet and Abbey came through as predicted. Sandman had some quail on the back course on the other side of a hill. Then a pheasant popped on him in the bird field before he could establish point. Time ran out before he could find another and that left him without a pointed bird. He got the H.M. for his efforts. Askim, my dog, was awesome in his eight find effort. Needless to say I thought the judges were brilliant in their decision.*

Take a peek, a careful peek at the open Top Ten list. Rebel Rousen Yankee is number 2. That is also where he placed in the Open Championship. The move to second place on the top ten is the result of placements in trials on four consecutive weekends (8-28 to 9-19). Yankee finished at the third of those trials. He was 2 years and 9½ months old. A month and a half later at 2 years and 11 months of age he takes second in a 2 series championship stake that has 35 of the best Vizslas in the country entered. In 1980 Yankee placed second in the puppy at the Nationals. In 1981 he placed second in the Derby. In 1982 he places second in the Open Championship. In addition to these successes in competition Yankee has been hunted all season in 1980 and 1981. He will again go hunting all season in 1982. It will be many years before any Vizsla tops Yankee's first three years.

Not too long ago Tom Harmer said "Jim, why don't we get the Nationals moved to the Spring." I told Tom that that sort of radical change would never be implemented by the VCA which has been ultra-conservative as far as the Nationals are concerned. However, the Puppy Stake has been eliminated and a 2 series Amateur Championship is now in place. Perhaps, a switch to a Spring (LATE MAY) Nationals would be a good idea.

The fall Nationals is unfair to the people in the Southwest. Competitors in the Northern states are ending two months of trials when the October Nationals are held. Competitors in the South are just coming out of the hot months and are just beginning their season.

There would be 4 additional hours of daylight each day in May than there is in October. Considering that the Amateur Championship is going to be a two series event, the need for more running time becomes real and urgent.

The Fall season in the North spans September and October. The Spring season spans March, April, May and even June. The mid-week Nationals kills 2 much needed fall weekends and forces Vizsla clubs to hold trials on the same date thereby cutting their entries.

The cover in the fall is so heavy that the gallery has trouble seeing the dogs. At the recently completed Nationals in Michigan, the dried golden rod kept the dogs from ranging and filled the air with cotton and seeds. It was so bad that it made little sense to ride and watch. You could see little or nothing. Horses that had been rented for the week stood unused. Horses that had been hauled many miles by their owner's also were standing around unused.

Our October date does not guarantee cool weather. The last five Nationals have been run in shirt-sleeve 80 degree + weather. The dogs handle the heat well. It would be no warmer in May. Freezing, wet, snowy weather has missed us only by days on several occasions. The May date would eliminate that danger.

Let's play it smart and switch to Spring. If you agree, write to Al Lucas, Lynn Worth and Tony Lucas.

Jim Busch said all of that!

5. Obedience Performance on leash is the basis of this test. If the dog follows on a loose leash or does so with a little encouragement, it gets an excellent to good rating. If it is fearful or immobile, fair. Fighting the leash is poor. Sitting when asked either voluntarily or after being shown how rates excellent to good marks. Sitting only when pushed or refusal are fair to poor. Coming on a voice command or with encouragement or a slight tug on the leash is considered excellent to good. If the dog allows itself to be pulled to the trainer, fair; resistance, poor. A dog that goes down almost at once or which does so after being shown how rates excellent to good. One which allows itself to be placed in the down position, fair; and one which gives outright resistance, poor.

6. Response to treats This is the final test. It is two fold, given to see if the dog responds readily to both food and praise and to see if it likes the food offered. A soft-moist food is used, accompanied by praise and petting.

Pheasant Sautéed With Apples

2 young pheasants, flour, butter, 1/3 cup Calvado or Applejack, S/p, 1/2 cup white wine, 1 cup heavy cream, beaten with 3 egg yolks. 6 apples sliced thin, 2 teas. sugar,

Flour pheasant, saute gently in 6-8 TBL.s butter til ivory colored, Flame with Calvado or Applejack turning once or twice in the jaiées. S/P, add wine Simmer for 8-10 mins. or just tender. Remove Pheasant and add few drops of Cal. or Applejack to pan. Slowly stir in the cream and egg yolk until sauce is smooth. Garnish with apples, sauteed in butter. Sprinkle on sugar.

Sautéed Quail

Split the birds and dust lightly with flour. Sauté in a mixture of butter & oil. Cook lightly on the skin side, turn and cook on the bone side, turn again. When nicely browned, reduce the heat, simmer til done, about 12-18 minutes. S/P to taste. Serve on fried toast with the finely chopped giblets which have been sauteed separately in butter.
