NEWS from the AMERICAN KENNEL CLUB. . . . . AKC will be holding an educational symposium at McCormick Place in Chicago, Illinois on Saturday, November 9, 1974. Fill out the coupon on the preceeding page and mail as soon as possible as it is on a first come first serve basis and only 2000 will be allowed.

On October 1, 1974, the revised provisions for determining a dog's eligibility as to height as specified in Chapter 19, Section 3, of the <u>Dog Show Rules</u> go into effect. The new provisions will have a three-fold impact: <u>First</u>, there will no longer be any measuring prior to judging. This means exhibitors will not be able to have their dogs measured before going into the ring. <u>Second</u>, there will be no measuring committees. The judge will make the height determination, while the dog is posed, at the judge's direction, by the handler of the dog. <u>Third</u>, height eligibility will be determined by means of a special "wicket." The wickets are much like oversized croquet wickets. The principle is that the legs of a wicket of known height will either touch or not touch the floor when placed on the highest point over a dog's shoulder blades, thus indicating whether the dog measures within the given height limit.



Another point I would like to make as far as All Age stakes are concerned is that it is a "FACT" that if a breeding program doesn't strive for All Age excellence, the quality of its gun dogs goes down!! I am going to end this article with a quote that every devout breeder or lover of this very nice dog should clip out and read every day or whenever someone comes up with the very stupid idea of closing stakes or eliminating the All Age and it goes like this: "History has disclosed the great gun dogs come from dynamic, aggressive, prepotent individuals. Without these brilliant, spectacular, hard driving, independent performers, consumed with a passion for finding birds, evincing unquestionable fire in the quest, needing "restraint" rather than encouragement, the splendid "shooting" dogs of the current era could not have been bred and developed."

Read this and believe it because it is a proven <u>FACT</u>! Don't let this fine breed go down the river because of some selfish people who desire a "Cheap" field champion!

## FALSE PREGNANCIES by Ralph E. Werner, Jr., V.M.D.

Abnormal behavior following a heat cycle (estrus) in the non-pregnant dog is rather common. The condition which occurs is termed false pregnancy (psuedocyesis, hyperluteoidism, pseudo-pregnancy). It is a hormonal imbalance and may cause a wide range of clinical signs.

Let us review briefly the narmal estrous cycle in the female in order to better visualize the abnormal. The onset of heat is characterized by swelling of the vulva and a bloody discharge which occurs for four to fourteen days. In most dogs the bloody discharge lasts about ten days. During this time the ovaries are preparing eggs for release. As the vaginal discharge changes from bloody to straw color, eggs are expelled from the ovaries. It is during this time fertilization will take place if she is bred and this period also lasts four to fourteen days. Again, for most dogs, eggs will be released from the ovaries for about ten days.

Following these stages the vulva will gradually return to normal size and the discharges will cease. The areas on the ovaries from which eggs erupted are termed follicles and they will undergo changes to become corpora lutea. These secrete the hormone progesterone which is necessary for maintaining a normal pregnancy. If no fertilization occurs, then the corpora lutea will regress in about one month and cease secretion of progesterone.

False pregnancy results when the corpora lutea persist and an excess of progesterone is secreted. This is admittedly an oversimplification of a complex process, but it serves to outline the basic hormonal cause.

Signs - Clinical signs vary considerably but almost always include increased size of the mammary glands and behavior changes. The onset of false pregnancy will usually fall between one and a half to three months after normal estrous cycle.

The mammary glands can enlarge slightly and produce a thick fluid or they may distend with actual milk up to the point of discomfort.

Behavior changes can range from aggressiveness and irritability to lethargy and shyness. Some dogs want to hide and avoid people while others seem to actively protect their phantom litter. Often a toy will be "adopted" and carried almost continually. Any type of behavior change following a heat cycle should make one suspect of this condition.

Other less common signs are slight fever, loss of appetite, and mild digestive disturbances such as diarrhea. The syndrome can appear from the first heat on and usually recurs with every cycle.

Treatment - Most mild cases do not require medication. In more severe cases, hormones, diuretics and tranquilizers may be used. No one drug seems extremely effective in treating this syndrome and each individual case should be left to the veterinarian. Due to the recurrent nature of

false pregnancy, serious consideration should be given to an ovariohysterectomy (spay), since this is the only permanent correction. Fortunately, in the majority of cases, this condition is not serious and will abate spontaneously. Many feel that pyometra (infected uterus) is more common in dogs having false pregnancies, but there is some evidence to refute this.

Summary - The important things to remember about false pregnancy are:

- a) it occurs shortly after a heat
- b) it often requires no treatment
- c) it is rarely serious
- d) it can be entirely prevented by ovariohysterectomy (spaying)
