- All stakes single course without a bird field.
- Wild and/or released quail and/or chukar, and/or pheasant used in **ALL** stakes.
- A blank pistol **will not** be fired in puppy stakes.
- Horseback handling will be permitted in all stakes **except** Amateur Walking Derby.
- The use of AKC Approved Tracking Collars will be permitted in all stakes and will follow AKC regulations pertaining to the use of tracking collars.
- Handler horses/wrangler will not be provided.

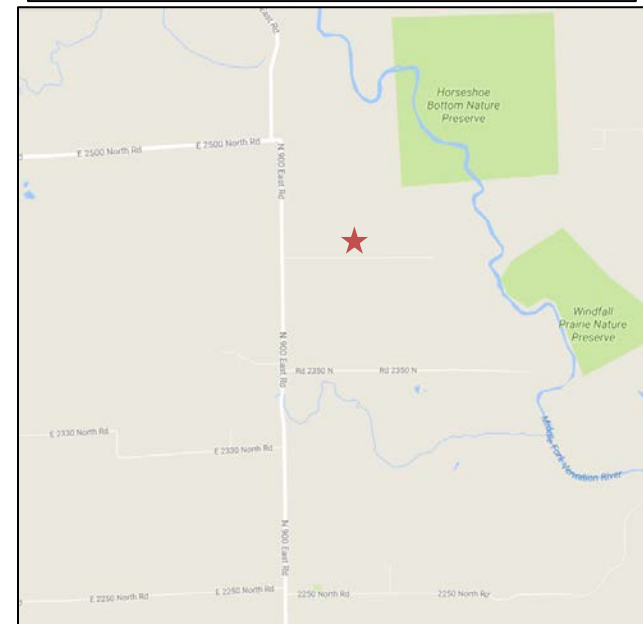
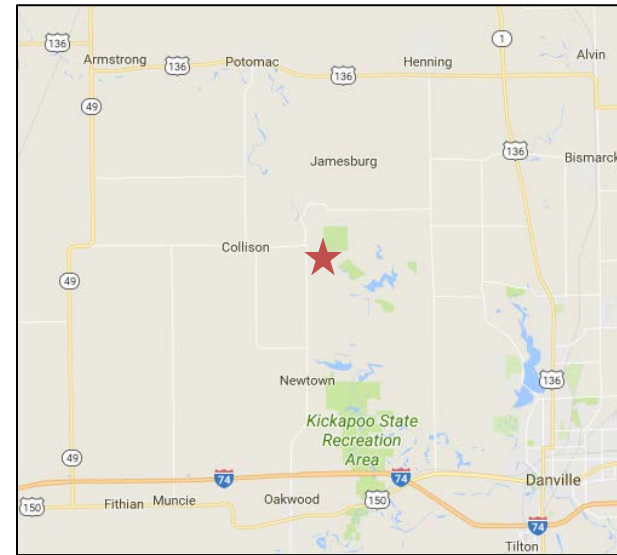
