#### \*American Field & AFTCA Win Certificates\*

The VCOI is a AFTC member The gun dog stakes qualify for handler points in the AFTCA Top Amateur Handler Award. In order for a win certificate to be issued, entries must include FDSB number and AFTCA member number. You must also be a registered member of AFTCA prior to the event in order for an amateur stakes win certificate to be issued.

## Parking/Camping

Camping is allowed on the grounds, but there are NO SERVICES and units must be self-contained. A \$10 camping fee will be due and payable for each night to the IDNR. Pit toilets are on the grounds.

## Wrangler

Handler horses/wrangler will <u>not</u> be provided.

#### **Horse Owners**

Everyone with horses is required to clean-up after them and place manure on the designated area located next to the barn

Those on grass areas need to scatter hay/straw refuse in the grass adjacent to them.

ANYONE with horses on the paved parking area must remove ALL hay, straw and manure from the pavement, prior to departure each day as required by the DNR and our agreement with them.

Water will be available onsite along with tubs.
