Per IL DNR, All rigs must be parked perpendicular to the grass areas.

Wrangler

Handler horses/wrangler will not be provided.

Horse Owners

Everyone with horses is required to clean-up after them and place manure on the designated area located next to the barn

Those on grass areas need to scatter hay/straw refuse in the grass adjacent to them.

ANYONE with horses on the paved parking area must remove ALL hay, straw and manure from the pavement, prior to departure each day as required by the DNR and our agreement with them.

Water will be available onsite along with tubs.
