# Tater Talks



My name is Tater. I am the son of Spike (Busch) and Ruby (Mitchell). I just turned 2 years old in April and it's been an exciting 2 years so far. When I was 4 months old, my human started me on a career in K-9 search and rescue training and I really excelled! At only 18 months old, I tested for national certification in area/wilderness search and passed my certification test on the very first try! This certifies me to search open areas like forest preserves, fields, or densely brushed spaces for missing or lost people. I can clear 40 acres of a wooded area in about 11 minutes, which is far more efficient and faster than humans. I am assigned to Disaster Dogs of Illinois (DDI) as their number 2 area/wilderness search K-9. DDI is a 501 (c)(3) charitable organization that trains, maintains and provides K-9 teams to law enforcement agencies and families of missing loved ones. We never, ever charge a fee for our services.

Recently, my partners and I were deployed to Pawnee, Illinois to search for a 64-year old man who went missing while searching for arrowheads in a cornfield. Our team spent 3 days, along with many ground searchers and his family, searching for him. To date, he is still missing.

On a happier note, last week we were deployed to Woodstock, Illinois to search for a 84-year old man who walked away from his home on a Friday morning. Some of my partners were dispatched that Friday night and I was on the scene at sunrise on Saturday morning. I am glad to report that the man was found in heavy brush about 4 blocks from his home, alive and well. He was dehydrated, bug-bitten and a bit confused after spending the night in the woods, but overall okay. He is now back home with his very grateful and relieved family.



In between training active searches, I participate in many of the DDI fundraisers and special appearances. DDI is funded solely by donations. We receive no Federal, State, or local funding.

I and my team at DDI remain on call 24/7, 365 days a year to assist those lost, trapped, or missing throughout the entire state of Illinois. # News From the Field Trial Clubs of Illinois

Good morning!

The FTICI held their Dog of The Year Banquet and general meeting on Saturday July 14, and BOD meeting on Sunday. At our general meeting, we had Jerry Johnson, Regional Manager of the Quail and Upland Game Alliance (QUGA) speak concerning the makeup of the organization and the progress on their many quail habitat and other projects. The QUGA is quite active and seeks to establish county chapters throughout the state. Many IL counties already have a chapter established. They welcome partnerships with individuals and other organizations to establish quail and upland bird habitat where the public may enjoy quail hunting and possibly dog training areas. The information was quite well received by those present. I highly recommend anyone with an interest in hunting or improving bird habitat to seek information from their website and consider joining a local QUGA chapter.

We also had a brief report from Dick Moss representing the Petersburg Merchants Fund and a check presented to FTICI for just over \$313. The check represents a 3% donation from participating Petersburg merchants of those receipts turned in by field trailers over the past year while at a Jim Edgar Panther Creek (JEPC) field trial. Dick provided a brief history of how the fund started and the appreciation of participating merchants for field trailers' business. The funds are provided to FTICI with the stipulation the funds be utilized at JEPC for improvements to or at the grounds. Dick also provided application forms to many of the meeting attendees. Receipts from participating merchants (including Los Rancheros, Corner Cafe, Shortstop Gas) and a completed form must be timely returned to the Riverbank Lodge for FTICI to receive the 3% reimbursement. I encourage you to bring your receipts to the Riverbank Lodge when you attend your next field trial at JEPC!

I am pleased to report the IL DNR has plans approved to bring electric to the stables, and also they will dig a well to provide easy access to water at the site. This is exciting news! I am hopeful this work will be completed soon, but Terry Musser of IL DNR advised us that work will probably not be completed in time for the Fall FT season.

The FTICI BOD voted to pursue a bid for the construction of a storage room adjacent to the barn at JEPC. This room could also be utilized as a shelter during field trials. Construction of a storage room is dependent on available funds and would probably take place when the electric and water sources are available at the site. As a reminder, FT dog fee funds paid to FTICI from member clubs are utilized for grounds improvements at DNR sites, such as funds needed for construction of this storage room. The VCOI is a FTICI member.

We had some real talented dogs and the judges had many dogs from which to choose.

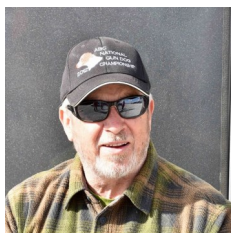
