U.S. Army Surgeon Restores Sight To Marine Sentry Dog. A brave U.S. Marine Corps sentry dog will soon return to action in Vietnam after a successful corneal transplant operation to restore it's sight.

The Alsatian, named Buddy, went blind after being hit by tear gas on patrol near the Cambodian border. Both corneas of the Vietnam veteran of two years were badly scarred, but only one cornea would accept grafting. The dog's handler, Cpl. Villiam Mathis, of Nashville, Ga. brought the dog to Saigon for the operation. Capt. Gunner Christiansen, an army surgeon worked nearly four hours on the delicate operation using the corneas of another Alsation killed by a car.

# Field Champion and Amateur Field Champion

This year (1971) the "Dog of the Year) award for German Breeds has been presented to a Vizsla. For the record, this is the first time any Vizsla has ever won this award.

This award is presented on accumulation of points for the number of trials entered by a dog, the placements he won, how many dogs were in that stake and how many dogs he beat out for that placement. The only trials that count are the trials that are run by Illinois Clubs and are members of the Field Trial Clubs of Illinois. This award is sponsored each year by this organization. Some 1,500 dogs are in compitition for this in the midwest area. In 1967, "Jodi" was 5th runner-up for the same award with this being the first time a Vizsla ever made their top ten list.

During the mast field trial year, Lew Simon, (Jodi's owner and handler) has worked and campaigned very hard to capture this award. He has been field trialing "Jodi" since he was a pup and did all the necessary training himself. Lew often admits that "Jodi" carried him for the first few years of trials while Lew was learning the ropes.

"Jodi" is the first male Vizsla to have won a Field Championship at the age of 3 years and he has been consistantly winning ever since. To date he has a total of 64 KC points with enough of these being major wins to make him a Field Champion six times.

All these are great feats for any breed of dog, extraordinary feats for a Vizsla, being a comparatively new breed on the American bird dog scene.

At present, "Jodi" is also the number one Vizsla Field Trial dog in the United States.

All stakes are open to Vizslas, German Short haired Pointers, German Wirehaired Pointers, Weimaraners, Brittany Spaniels, Irish Setters, and Gordon Setters. Mr. Bob Brenner and Mr. Dave Hill have accepted our invitations to judge the Open Gun, Open All-Age, and the Open Derby. Mr. Woody Ross and Our President Tony Lucas have also accepted our invitations to judge the Open Puppy, Amateur Gun, and the Open Limited Gun Dog stakes.

Standard AKC rosettes will be given to all placed dogs, and trophies will be given to all first places except in the Open Limited Gun Dog. A cash prize will go to-first and second place dog in the Open Limited Gun Dog stake.

The Judges Banquet will be held on Saturday, March 25th, at the Voyager Inn located at Interstate 80 and and Illinois Route 26 ( Prinston Exit of I-80. ) Socktails at 7 o'clock, dinner at 8 o 'clock. The cost of the dinner will be \$ 3.75 per person

\* A PAT'S SECURITY CRATE \*

Dogs are among the territorial animals. They'll protect their territory from strange animals in various ways. Some by barking, some by growling, some by just running around in excitement.

But within that territory there's a place they go to rest. They'll choose a quiet, preferably dark place with cover overhead and on three sides if possible. Here they make no sound, for any noise night attract an enemy, and they will not soil their pest, because this would allow their enemies to scent them. This is their nest, their shelter, their den.

Your dog's territory is your house and your yard, which he will protect in his own way. But within that territory he needs a haven, some place of his own where he can be quiet and secure to rest.

The best kind of training involves understanding and using the dog's built-in behavior patterns. Man has a concept of freedom that makes him believe all animals must be free. Yet, when man is sick or frightened, he will seek a quiet, safe place. So will a dog if you provide him with such a place.

Our dog's are sound asless at the moment, each in her own crate. The crate doors are open, and no one told them to "go to bed". But there are times we use this command, and they obey.

I strongly recommend that anyone with a new puppy invest in a crate where he can feel secure when he wants to rest or sleep. It will be far easier to housebreak him, and he will learn to be quiet there. It will keep him out of mischief when you're not around to watch him, and when he matures, he will accept it as his haven, his nest, the place to go when the children get too rough; when he wants to chew on his treasured bone, or just take a nap.

## \* Old Dog's Best Friend \*

#### Front cover-Center

Field Champion & Amateur Field Champion "Jodi" of Czuki Barat, (M) 6/2/64 Owned by: Lew & Sharon Simon, Antioch, Ill.

"Jodi" is the first male Vizsla to have won a Field Championship at the age of 3 years. To date "Jodi" has won 21-- 1st field placements enough to make him a field champion six times over. His latest accomplishment was winning the Field Trial Clubs of Illinois "1971 DOG OF THE YEAR" award for German Pointing Breeds. This award has never before been won by a Vizsla--over 1,500 dogs were in competition for the award. "Jodi" has sired both bench and field champions and is still actively campaigned in field competition.

Amber, in the words of her owner, is a super animated dog who finished her show championship in June 1967 and her field championship March 1971. She made history in 1970 when she won both the National Specialty Show and the VCOA Fall National one-hour Limited All-Age Stake. Her producery show she is a proven producer.

the Vizsla breed was recognized by AKC (which hapnened on Thanksgiving Day, 1960). She is part of what is known as the "Foundation Stock" of the breed. Goldie won her Companion Dog title in 1962. She is still used as a hunter at the age of  $11\frac{1}{2}$ , and still doing an excellent job in the field.

Field Champion and Amateur Field Champion Amber's Vindy Autumn, (F) 2/28/68 Dwned by: Phil Rosenberg, Wheaton, Ill.

"Windy" is the youngest Vizela to finish in the field, winning a 5 point Open and a 4 point Amateur Gun in the 1971 VCOA National Trial. She was five weeks past her third birthday when she finished. The next week at the GCPC of Michigan Field Trial Windy won her Amateur Field Championship with a 3 point victory in the Amateur Gun making her the first Vizel Amateur Champion recorded with AKC. As of this printing Windy has placed in 26 Gun Dog field trials of which 10 were blue ribbons earning a total of 30 points against all-breed compitition.

Jil carned her bench championship on June 1,1969 after being shown 9 times between March and June of 1969. In the 9 shows that she won, she was Best of Breed 4 times and Best of Op osite Sex 3 times. Her biggest win was in April of 1969 when she took Best of Breed at the International Kennel Club Show. Jil has always been an excellent hunter in the field.
