

"Training the Hunting Dog" continued

Introducing the Gun - This must be done with great care. Gun shyness is nearly always man-made by too hasty or incorrect training to the gun. And the cure is a long, sometimes impossible, process.

Association of noise with the puppy's feeding time is a well proven method of leading up to the noise of a gun. As you approach with the puppy's pan of food, gang a metal spoon or another pan against it. Not too loud or too near at first but gradually making a great racket as you bring his food to him.

After the pup has become well used to this noise and pays no attention to it, try 2 . 22 blank starting pistol in the same way, shooting only once at distance of 40 or 50 yards. In a couple of weeks and depending on the pup's acceptance of the pistol, begin to decrease the distance between the shot and putting his food before him. When he's entirely unconcerned about the pistol, use a light gauge gun (a .410, preferably, or 20 gauge) as a signal that dinner's arriving. Again,

shoot only once at 50 yards, determining by observing your pup how long to wait before shooting a little closer.

Even though your pup is completely happy with this situation, don't relax your care in introducing the gun in the field. There can be many a slip between acceptance of the noise of gun fire at home and in the field.

The Gun in the Field - The blank pistol is a good way to start, shooting it at first at long distance from the youngster while he's busily investigating some cover or running eagerly. Choose the time you shoot and, progressively, how near and often you can do so by observing how the pup reacts.

The actual gun, and again a .410 or 20, can usually be introduced when the pup is several months old and has become keenly interested in hunting. Carry the gun for several trips afield so he gets used to seeing it. Even swing it up now and then as if to shoot, but don't.

The first time you shoot it, do it at a distance of some 40 yards and pick a time when the pup is chasing a bird or deeply absorbed in searching the cover. He may stop momentarily and look towards you. Keep walking as if nothing had happened. He'll probably continue hunting. Don't shoot more than once or twice that day. If the sudden noise prompts him to come in and walk at your heels and he remains close, don't shoot again for the next few days. Just carry the gun and wait for another propitious time to shoot.

In training retrievers, very often introducing the gun in the field follows previous training to "fetch" the dummy. Have an assistant do the shooting. The method is to put the dog on a long lead or cord, have him "sit" and then throw the dummy far out so it comes down in the open where the dog can see it. While the dummy is still in the air, the assistant, standing off to the side, shoots a blank pistol. In eagerness to make the retrieve the dog will probably break but he's allowed to for it's getting him used to the gun that's important now. When the time comes to make him stay steady, hold the end of the lead, jerk on it to hold him when he starts to move, make him sit again, stroke him and when he's calmed down, drop the lead and send him.

The next step is to have the assistant use a shotgun, about 40 yards distant at first, each time the dog is sent to retrieve. As he gets accustomed to the gun's noise, the assistant can gradually move closer. Take care in chastising a dog for breaking so he won't associate it with the gun.

These lessons must be practised for a short time each day, taking about two months before the training is accomplished. Eventually a dead game bird is substituted for the dummy and thrown into cover as well as in the open so the dog will learn to hunt for game scent.

During training sessions there should be no distracting influences, so don't show off your dog's accomplishments before a group too soon. And never take your dog hunting for the first few times with more than one or two companions who can be trusted to consider your dog and not blast away with their guns indiscriminately.

Introduction to Water - All dogs can swim if they have to. But you want your dog to have the desire to swim so he'll go into water at your command, confident and without hesitation to retrieve game. Even a pup "born and bred" for water can be ruined if his first experience is frightening.

Wait until the puppy is at least twelve weeks old before starting him in water. Choose a warm day and the edge of a pond or lake where it's shallow and the bottom gives firm footing. If possible, take a few pups together as they will encourage each other. An older, experienced dog can be helpful, too.

Put on waders or wear a bathing suit so you can go in. Splashing about in your waders and talking to the pup will encourage him to join you. Stay only where the pup has footing for the first few sessions. As he gets bolder, wade out farther so he'll begin to swim to stay with you. Practically all pupples "climb" or swim awkwardly at first, raising their front feet high and splashing up water. If your pup has played about in shallow water often that shouldn't bother him too much and before long he'll begin to swim in a natural, easy way.

After a pup has learned to retrieve the dummy on land he'll do it as eagerly from water. Throw it a short distance at first, increasing the distance as the pup progresses.

As in other training, don't prolong water work. Stop while the pup is enjoying it.
