# SPRING FIELD TRIAL "79

March 10 & 11th. Des Plaines Wildlife Area. Joliet. Illinois

Saturday: Open Derby on course I, and Open Gun Dog and Amateur Limited Gun Dog on course II.

Sundayı Open Puppy on course I, and Open Limited Gun Dog and Amateur Gun Dog on course II.

Open Gun Dog, Amateur Gun Dog, and Open Derby are for Vizslas only. Open Limited Gun Dog, Amateur Limited Gun Dog, and Open Puppy open to all breeds. No bird fields, all gun dog retrieving stakes are call backs with one dog, his owner, and We will use a modified continuous course arrangement for three Quail Gun Dog stakes. Quail will be in coveys kept together by a call bird in a cage in a tree. Used this sytem last spring and had spectacular results. Lots of covey finds each brace.

We will be altering courses so coveys are used no more than once every 12 hours. All gun dog stakes will use the grounds across from the building. The two young dog stakes will use the grounds on the same side of the road as the building and will avoid the bad cover east.

in a holiday toast. and partook of hors d'oeuvres of which the restaurant could boast.


The hours flew by quickly with events that followed dinner,

The number in parenthesis represents the top ten points that were earned in limited stakes and all age stakes. They give an indication of the quality of top ten points that each dog has earned.

The Vizsla Club of America's Board of Directors voted at the meeting held recently in Illinois to stop printing comments by the people who accummulate the information that goes into the preparation of the top ten lists. Since each of us (top ten preparers) do this work Free and voluntarily, this edict by the VCA Board amounts to a striping away of the fun associated with this job. I'll keep doing it for awhile, but not for as long as I would have if not for the "GAG". Therefore, if you have enjoyed the comments I have printed after the Top Ten Field list, you will have to subscribe to the Vizsla Club of Illinois bulletin to continue enjoying the comments. They will not be printed in the VIZSLA NEWS from the national club any longer.

The Top Ten Pield computations were started by VCOI's own Phil Rosenberg about eight years ago. I have all of Phil's records and of course all of my own. To my knowledge, this is the only record of Vizsla field successes eutside of the archives of the American Kennel Club. What the VCA appears to forget is that these records belong to Jim Busch and Phil Rosenberg (who gave his records to Jim Busch) whe each prepared Top Ten lists for the VCOI bulletin and allowed them to be reprinted in the VCA News.

Two years ago I requested that the VCA change the method of Top Ten computation - only a portion of my suggestion was accepted. This year, once again, I requested that the VCA Board revise the method of field top ten computation. Once again, they turned down my suggestion. I guess that once again the VCOI will have to lead the way and by example in their bulletin show the National Club how effective and efficacious a different method of top ten field computation can be.

I will continue to send the Vizsla Club of America News top ten field lists computed by what I choose to call the "expensive (to all of us)- quantity counts" system. The Vizsla Club of Illinois bulletin will receive the top ten field lists computed by the "inexpensive - quality counts" system.

As presently constituted, if you own a Vizsla Gun Dog and would like to have him be on the top ten list, it is beneficial that you enter as many stakes each weekend as possible to maximize your chances of earning top tenpoints. Quantity is essential. This system of selecting the best dogs does work in the sense that, for the most part, the best dogs do tend to appear on the top ten field list. HOWEVER, the same results can be obtained at a far lesser expense to the Vizsla field trial community by only using the placements from one designated stake at each field trial.

Once a year Phil and I have compiled an Amateur Top Ten field list to be purlished once at the end of the year. This is an arema of competition all unto itself. Why only once a year? I propose to publish this list as often as the other, but once again, only using one designated stake from each trial. I propose to call these lists:

a. the Open Top Ten Field List b. the Amateur Top Ten Field List Points will be computed as they are for the current top ten list, i.e.,

lst place is 4 points 2nd place is 3 points

3rd place is 2 points times the number of dogs defeated equals points/placement.

For the Open Top Ten list only, placements in the Open Ltd. Gun Dog stake at each trial will be used. If no Open Ltd. is offered, the Open Gun Dog stake will be used.

For the Amateur Tep Ten Field list only placements in the Amateur Ltd. Gun Dog stake at each trial will be used. If no Amateur Ltd., the Amateur Gun Dog stake will be used.

In this way, a Gun Dog owner can compete for a slot on a Top Ten list by entering only one event a weekend. This should enable competitors with limited funds to keep a talented dog in the lime-light. It will encourage the owner of a talented older dog to keep him in the lime-light. It will allow someone to keep a dog in the lime-light of the top ten and simultaneously begin developing another gun dog without going broke I have kept parallel records for four years now and am convinced that the quality of the top ten dogs will not be diminished. On the contrary, it appears that the quality of the dogs on the top ten list is enhanced, thereby making these an even greater aid to breeders (which is the only valid reason for their existence).

The VCOI bulletin will not print a Puppy/Derby top ten list. The reason for the existence of the Puppy/Derby list is cloudy at best. Too many times dogs that could not win a first in a Puppy or Derby stake have occupied top ten slots and Puppy & Derby stake winners remained unrecognized by the VCA News merely because the former were entered a lot and placed while the latter won their points and retired to the side lines to await the older dog stakes.

In place of the top ten puppy/Derby list, I intend to print a listing of all those young dogs who have earned their puppy and/or derby points, i.e., first place dogs. Their names will be printed when the placement appears in the GAZETTE and will remain printed as long as they remain a puppy - in the case of winning puppy points, or a derby - in the case of winning derby points. The listing for each dog so honored will include dog's name; titles; notation of P(2) and/or D(3) indicating puppy and/or derby wins; size of stake, i.e., (1) I point, (2) 2 points; sire-dam; owner, date of birth. A typical listing would look like this:

I have talked to plenty of people who have entered and entered and entered their young dogs for no other reason than to earn top ten points. Most regret entering that many stakes. Many indicated that they created problems in their dogs that were caused by the endless Puppy/Derby competition. These comments were from professional handlers as well as amateurs.

This New and Better Way of Top Ten reportage will begin when the 1979 results appear in the AKC GAZETTE. Hopefully, after a year or so of watching the VCOI lead the way, the VCA will request that I report the top ten to the VCA News in the same manner.

As the new editor of the ! linois bulletin, let me say that although this is "old hat", it will take some getting used to again. I have changed this particular issue four times due to the fact that I haven't been able to get to a printer because of the sNow storms (remember we really do live in the boonies). However, I know there are still mistakes and it should be arranged a little differently, but I can stand to look at it one more attill!

## THE BITE IS WORSE THAN THE BARK

For the most part, dogs are loyal and affectionate. Many will protect their masters to the point of risking their own lives. Their barking can frighten a burglar away and awaken a sleeping family to the danger of fire.

Now comes the saddest words in any language - "but." A dog is man's best friend but: more than a million Americans will be bitten by dogs this year, and at least a million other cases will go unreported.

Most of the victims will be children. Most of the bites will be inflicted by dogs whose owners allow them to run loose, despite leash laws. The bites will cost the public an estimated \$30 to \$50 million in medical treatment and settlement of litigation.

Once a dog bites a human and learns he can get away with it, he may bite any human; adult or child (including you and yours), other loved ones, friends and visitors, and service personnel.

The following precautions represent a consensus of experts:

- If you own a dog, you must always make him understand that you are his master. If he doesn't respect you, he'll rarely respect anyone else. And, if he'll bite a stranger, sooner or later he may bite you or a family member - a vicious circle indeed.
- If your dog isn't instantly and sevdrely reprimanded for a bite, growl or any act of aggression toward your family or harmless strangers, he'll regard that as approval for potentially dangerous behavior. The important word is instantly, for dogs have short memories; if you wait for only 10 seconds he probably won't understand why he's being reprimanded.
- If a dog is kept in the home and not exposed routinely to strangers, he'll be more likely to bite when he's exposed to or handled by strangers. (From his protective point of view, the dog may regard them as threats to him and you.)
- Expose him as regularly as you can to strangers and visitors and let him know they're harmless - while you keep a watchful eye on your watch dog.
- Never let your dog run loose in the neighborhood. Walk him with a leash. If your yard has a fence too high to jump or climb; he can stay there under supervision (with a collar and chain if necessary).
- If you find you can't control your dog's behavior, take him to a professional dog trainer or to an obedience class where experts will teach you and your dog what you need to know about good canine manners. So much for your dog. Now, about those other dogs:

- Never let children approach a strange dog unless the owner is present and permission is given. Look for these signs of a wary dog: ears back, head down, tail between legs, shifting continually.
- That dog doesn't want to be approached. If he runs up to a child, the child should not look at the animal (looking a strange dog in the eye can make him angry for he may regard it as a threat or challenge).
- Nor should the child (or adult) make any quick moves or loud noises. Instead, the child should look for a safe place such as an enclosed yard or porch, then walk, not run, to safety.
- If you know whose dog it is, tell the owner about the incident and demand that his dog be leashed at all times. If the dog is a stray, notify your city dog warden.
- If you meet a dog while you're out walking, ignore it. If you're carrying something in your hand, tuck it under your arm. The swinging motion of the object may excite him.
- If the dog growls at you or looks like he wants to bite you, stand perfectly still. Keep your hands at your sides and try to pretend he isn't there - he'll probably lose interest and go away. If he doesn't, calmly continue walking.
- If he attacks you, fold your arms, grabbing each elbow with the hand of the other arm, and thrust your arms up quickly in front of your face. Depending on the size of the dog, youmay be able to knock it off balance.
- If the dog knocks you down, roll as fast as you can onto your stomach and protect your head and neck with your arms. Don't move.
- If you or a family member are bitten by a dog, immediately wash the wound and surrounding area with scap and water, making sure you wash away all saliva. Then irrigate the wound by running very warm water on it.
- Cover the bite with sterile gauze and go to your doctor or hospital as quickly as possible.
- Report the bite to police...all bites must be reported. If the dog doesn't have a rables inoculation, it must be impounded for 10 days for a rables inspection. (Rables in a human usually causes death.)
- If the dog is a stray and can't be caught right and, try to remember its color, size, breed and special markings so you or the victim can avoid that series of 21 shots.
- A final safety tip for everyone to remember....never tease or provoke any dog whether you know it or not.

Dogs are man's best friends but (there's that word again!) to keep that friendship, you must treat them properly and give them the respect you expect from them.
