Treasury: The Treasurer shall reconcile the club financials in Quicken and provide a written check register at every meeting. These threats come in the form of breed-specific legislation, mandatory spay/neuter laws, mandatory leash laws (which outlaw off-leash dog parks), bans on breeding any animals within certain locations, bans on tail docking and dewclaw removal, and even attempts to pass laws that would mandate euthanasia of any dog that disturbs any wild animal. These types of laws are the "foot in the door" for animal rights organizations such as the HSUS and PeTA whose ultimate goal is to have a "No birth nation" and to end all hunting of any kind. The way to defeat their agenda is to vote only for those candidates who actively support the rights of the people to hunt, fish, and breed animals.

The Sportsmen and Animal Owner Voting if we can expect to enjoy our Vizslas in the Alliance (SAOVA) has a running list of future. endorsed candidates across the country. themselves as friends of the sporting enthusiast through their voting record, or have answered the SAOVA questionnaire in such a way to earn the endorsement. The list as of May, 2004 is included in the meeting minutes. A current candidate list can be viewed online at www.saova.org. Another resource is the AKC website, www.akc.org, and click on the Legislative Alerts link.

For those who think I am an alarmist or paranoid, I urge you to do some internet research on animal rights groups simply by typing "animal rights" into any search engine. You will be shocked at the amount of matches you will find. Spend some time on the Humane Society of the United States website, and type "hunting" into their site's search engine. 

Please bring a comfortable **chair** for yourself. As if you'll want to use it for even a second.

Park your vehicle along the perimeter areas along the driveway west of the yard area to leave room for all our events. There are no poop bags allowed at the Busch Farm and the horses create enough fertilizer. So, all poop gets scooped (except out in the field) and placed in buckets. RESEARCH FINDS DOGS UNDERSTAND LANGUAGE

attest, our furry friends are listening. Now, for asked him to fetch a toy, using a name for the doubters, there is scientific proof they understand much of what they hear.

German researchers have found a border collie named Rico who understands more than 200 words and can learn new ones as quickly as many children.

Patti Strand, an American Kennel Club board member, called the report ``good news for those of us who talk to our dogs."

"Like parents of toddlers, we learned long ago the importance of spelling key words like bath, pill or vet when speaking in front of our dogs," Strand said. "Thanks to the researchers who've proven that people who communicators, not just a bunch of Leipzig. eccentrics."

The researchers found that Rico knows the names of dozens of play toys and can find the one called for by his owner. That is a vocabulary size about the same as apes, dolphins and parrots trained to understand words, the researchers say.

Rico can even take the next step, figuring out what a new word means.

The researchers put several known toys in a room along with one that Rico had not seen understand a lot," Fischer said. The team

noted that dogs have evolved with humans and have been selected for their ability to respond to the communications of people.

life sciences, said "such fast, one-trial learning in dogs is remarkable. This ability suggests that the brain structures that support this kind of learning are not unique to humans and may have formed the evolutionary basis of some of the advanced language abilities of humans."

Perhaps, although Paul Bloom of Yale University urges caution.

"Children can understand words used in a range of contexts. Rico's understanding is manifested in his fetching behavior," Bloom writes in a commentary, also in Science.

Bloom calls for further experiments to answer several questions: Can Rico learn a word for something other than a small object to be fetched? Can he display knowledge of a word in some way other than fetching? Can he follow an instruction not to fetch something?

Fischer and her colleagues are still working with Rico to see if he can understand requests to put toys in boxes or to bring them to certain people. Rico was born in December 1994 and lives with his owners. He was tested at home.




