



A DOG'S LIFE FOR LUCKY MUTTS

Mantovani's music is for the dogs.

And the cats, and any other pets lucky enough to be boarded....er....have room reservations in the American Pet Motel being built near north suburban Prairie View.

The guests will be bedded in the lap of luxury, ranging from tiny brass beds with mattresses for dogs in the Imperial Suites to sturdy wooden pallets on carpeted floors in the Deluxe Suites.

Pets will be serenaded during the day by Mantovani and other artists through a piped in music system.

And at night the dogs will be lulled to sleep by the happy sounds of cars, fire engines and other familiar street noises.

"That's so they don't start barking at the least thing," explained President Robert Leeds of the motel organization.

The music will be selected to appeal to the cats, dogs and other pets to be housed at the million-dollar facility in Lake County on Aptakisic Road, a mile west of Milwaukee Avenue.

Perhaps the motel is too far away? Don't give it a thought. A \$25,000 van with air-conditioning, music, base-board heating and an antiseptic filtration system will pick up your pooch or cat at the door. "The van will be a total environment," explained Leeds.

Once inside the motel for their getaway weekend, dogs will have the of N D in indian and outdoor, a choice of prime digraphs and fresh running water.

Twice a day, dogs in the Invenial Suites will have cookie breaks. A human being will enter each dog's room, make him sit up or roll over or whatever the animal's specialty is. Then, after a few pats on the head, cookies will be offered.

Dogs in Deluxe Suites also will get cookies, but without the tom-foolery.

For those finicky eaters, a complete kitchen will prepare full meals to be turned, into table scraps.

Leeds said pet owners can also have fish, snakes, birds or even an elephant.

"We'd probably put the elephant in the barn," he said.

A veterinarian will be on call 24 hours a day. Each room will be connected to a negative electron system that will take masty dust particles out of the air, and bactericidal lamps will remove germs.

The rate will be about \$2.75 a night for deluxe and up to \$8 a night in the Imperial Suites. On second thought, leave the doe at home and so there yourself.

DEMODECTIC MANGE

Mange is an intensely reddened skin condition of young dogs that results in excessive scratching and loss of hair. The mite is usually part of the normal fauna of canine skin and is present in very small numbers on most healthy dogs. The condition occurs almost exclusively in young dogs (three mos. to 1 yr). When the disease is seen in older dogs, one can be sure they have had it since their younger days. There is usually some predetection for short-haired breeds. Usually pupp acquire the mite from their mother during the lactation period.

Two general types of demodectic mange are encountered, localized and generalized. In localized, a patch of sk developes the redness along with some loss of hair. There is generally no itching. The most common area involved is in the face; particularly ground the eyes and sides of the mouth. Most cases of this type are observed in dogs three to six months of age. If it isn't properly attended to, it could develop into the general form.

The generalized form begins as a localized patch but instead of improving, it rapidly spreads to the legs and trunk. Each small area involved increases in size until the entire animal is covered. Usually the generalized form is further complicated by the presence of the skin tacteria (Staphylococcus aureus). This complication develops the typical crusty, bleeding, exudative type sores that are encountered in most chronic cases of mange.

The control of mange is approached on an individual basis and it will depend greatly upon the direction and extent of the condition. Shampoos and dips are generall indicated in the early stages of control; however, it must be remembered that recovery is not rapid, but may require from four to ten weeks of effort before full recovery is obtained.
