What is Futurity?

During a recent visit with the Busch's I asked this question. Jim was more than happy to explain and give me past articles he has written on the subject. Here is a summary of that information updated with the current information from the VCOI website.

A Futurity is a field competition for young dogs. For Vizslas it takes place in the spring of each year (1st Friday in March) just before the VCOI field trial. The Futurity has a great deal of prestige associated with it. Vizslas that enter are the cream of the young field Vizslas. The Vizsla that wins takes home a giant trophy, a substantial cash purse, and a lot of great press. For most, winning the Futurity is a once in a lifetime, never to be forgotten event.

The Futurity was conceived, launched, and run by Hank & Betty Rozanek in 1983. Starting in 1993 the Midwest Vizsla Futurity (MVF) has been managed by the Vizsla Club of All placements must be awarded. Illinois and held at the Des Plaines Wildlife Area near Joliet, Illinois.

The entry process for the Futurity begins when the breeder of a litter fills out the "Litter Nomination Form" and submits a check to the Futurity Secretary, Rodney Albin. This must be done within 90 days of the birth of the litter.

Pups from nominated litters must be renominated prior to its first birthday for an additional fee. A pup may be renominated within 90 days of its first birthday for an additional late fee. This is the last nomination required to keep the pup eligible.

This is what I thought was key: If you have a puppy from an un-nominated litter you can still nominate your pup. You will need to fill out the Self-Nomination Form (found on the VCOI website) and send a check to the MVF Secretary within 9 months of the puppy's birth

(American Kennel Club) or FDSB (Field Dog Stud Book) are eligible.

Entry forms will be sent to all eligible Vizslas (those that have paid the fees and filled out the forms) in early February—usually about the time our field trial premiums are mailed. There is an additional entry fee.

When your Futurity puppy will compete depends on its birth date:

Pups born 2-1-06 to 1-31-07 will run this year. Pups born 2-1-07 to 1-31-08 will run in 2010.

The course will be a 30-minute single course with no bird field. Birds will be released on the course. Horseback handling is permitted. Dogs may be called back for any reason at the discretion of the judges. Dogs will be run in braces as drawn. If a brace mate is not present to run, the other dog will run alone. Bitches in season will be run last.

The MVF will be judged using derby requirements: all placed dogs must point staunchly.

Judging emphasis is to be placed on dogs that show a keen desire to hunt, are bold and independent, have a fast vet attractive style of running, and demonstrate intelligence in seeking objectives. Dogs should point staunchly and may be called back for a point.

The MVF was established for the purpose of encouraging the owners of Vizslas to breed for the highest field standards. A substantial cash prize awarded to both the owners and the breeders of the winning dogs is intended as an incentive for practicing these high breeding standards.

You may have noticed that I did not include any pricing in this article. That is because there is a committee being formed for the purpose of updating the rules and prices. Watch for the updated pricing in future Bulletins.
