“I went to Busch’s to buy a hunting dog” .... a familiar story? Mom said – NO! – but fell in love with her irresistibly sweet personality. And then she kept running away and Busch said “Try one of those hunt tests - you’ll have fun.” He never mentioned the addiction (where is the warning label?). She went to “Junior Hunter” in 4 straight passes at 11 months/old with a handler who never even seen a field or hunt trial before. And then there was a “Puppy” Field Trial. Again, “Busch said ....” She took her first blue ribbon just before her first birthday.

Then my back went out and Jerry Jordan stepped in for a while until her right foot got sick. So we came home, and the partially-crippled and the partially-trained tried to field trial together. Until Mark Spurgeon very compassionately told me “Joe, you’re just not fit to handle a dog like that. She’s better than you can give her”. He was right: I was shot: Brian was there: and KA-ZOOM! Less than a year later she finished her FIELD CHAMPIONSHIP (at 2 yrs. 7 mos. old) and ended her first full competition season (2011) in the TOP TEN (at #4, right behind Ruger).



She lives in a Chicago house on a typical lot, with a small backyard. There are no horses or kennels or bird fields. We are stunned at her performance and success. So we know SAGE’s success is a reflection of everyone reading this page. She is the product of great – brilliant – breeding: not just by Linda and Jim Busch, but also by everyone else who has a dog back in her pedigree. Many, many thoughtful breeders put together the scaffold of her tough little genetic package: Linda & Jim finished the package off perfectly.

Next, she had great talent to put her potential to work. Brian Gingrich has established himself in our hearts as an outstanding trainer who really understands these heroic red dogs – teaches them, coaches them, coaxes them, excites them into a love of running and finding birds. Jerry Jordan started her with a gentle hand and a graceful manner that let her understand the training process is fun. Jerry, we love ya, pal ! – it was just the distance & gas.

And, finally, there is the landscape of her life and her sport – a landscape shaped not of stone mountains and forested hills but of terrific people and great heritages – with names like Spurgeon, Englesman, Gingrich, Nowak, LePoudre, Kliefoth, Rodney Albin, Greg Wegler, Mark Johnson, Greg Hedien, Chadwell & Browne, Haines, Booker, Boggs, Michel Berner, Michelle Princer, Jodi Cieslak —planting birds, organizing the trials, monitoring legislation, judging the events in the rain, staying until the last brace is back – countless names we don’t remember and people whom we never really met like Tony & Gina Ordonez (Gina: 10 years ago you gave 45 minutes of your time on the phone to a complete stranger when I was thinking about buying our 1<sup>st</sup> vizsla). Each one of you has made this breed smarter, stronger, faster, more loving and more fun.

Fifty years of modern American cultivation of, and love for, these ancient Hungarian dogs has bred into SAGE a love of running and hunting and she surely runs for the love of it. All of you that are this VCOI “VIZSLA NATION” hold the undying gratitude of our family for the genetics, the intense yet congenial competition, the events and the applause that let this little dog stretch out those long, hard runs. The awards this dog carries are awards genuinely earned by the VCOI – for your support, your encouragement, your friendship, and for her, we thank you.

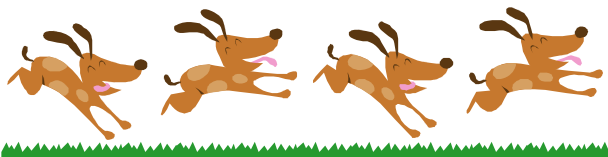

## The 2012 Midwest Vizsla Futurity

This year marks the 30<sup>th</sup> Anniversary of the Midwest Vizsla Futurity! This year's event will be held on March 9, 2012, on the West Grounds of the Des Plaines Wildlife Area in Joliet, Illinois. Entries for the 2012 Futurity will close at 7:00 p.m., on Thursday, March 8, 2012, and the drawing will be held immediately after closing in the clubhouse. Entries may be made in person up until closing time at the grounds, or mailed beforehand to the MVF Secretary, Rodney Albin, 2445 Carter Road, Moscow Mills, MO 63362. The fee for entry in this year's Futurity is \$75.00. Our judges will be Mr. Kent Harter of Hampshire, IL, and Mr. Jim West, of Randolph, IA.

For those that are not familiar with the Futurity, it is a 30 minute derby stake run under the American Field but with its own rules, the most notable being that all placing dogs must have a staunchly pointed bird. Only nominated dogs may participate, and bitches in season may be run. Go to <http://www.vizslafuturity.com> for additional information about the MVF Rules and Regulations, litter nominations and pup re-nominations, and for reports and photos from previous years.

Year in and year out, the MVF showcases many of the best derby dogs our breed has to offer. Yet again, this year will be no exception. From the seventeen litters nominated for the 2012 Futurity, twenty six dogs have been re-nominated thus far and we anticipate more than twenty of those hopefuls to be drawn and run.

The Winner of the Futurity is awarded the highly coveted "Double Lane Dog" trophy, and the 1st, 2nd and 3rd Runner Ups all receive "Single Lane Dog" trophies. A cash purse is also divided among the winners, with a portion of the purse going to the breeder of the winning dogs (provided that they nominated the litter). The breeder of the winning dog is also given a Breeder Plaque if they nominated the litter.

Even if you don't have a derby nominated to run this March, this is an event worth attending just to watch. Who knows what next great superstar you might see? Plus, you can come for the MVF and stay for the VCOI spring field trial on the weekend.

For those who have a litter that was recently born, or is about to be born, I would encourage you to nominate your litter for the Futurity. For those with young dogs, pups can still be self-nominated and run next year, so don't delay. In the words of the Futurity's founding father, Hank Rozanek, we need to "keep them pups nominated."

## Recipe Corner



1 side salmon

This can be with skin on or off.

Usually a side of salmon is about 2 1/2 pounds.

1 cup soy sauce.

1 teaspoon black pepper

2 tablespoons olive oil

3 teaspoons sugar

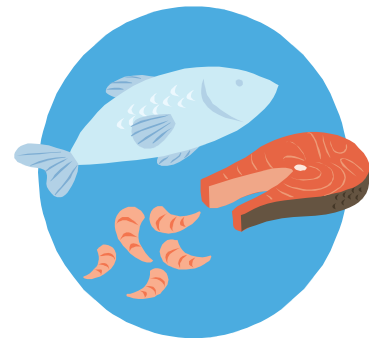
Mix all ingrediants together.

Marinate salmon for 1 hour or overnight in refrigertor.

Prepare smoker using fruitwoods and the lowest temperature. Take salmon out of marinade. Rub into salmon 1-2 teaspoons kosher salt. Place in smoker for about 2-3 hours. If weather is cold let salmon sit in smoker for another hour with door shut. If weather is hot take and place salmon in refrigerator to chill. Garnish with tomatoes, onions, sour cream, hard boiled eggs, green onions and toast points. It is ready to serve.

Special note...it is important to occassionally check salmon while smoking. You want to smoke it longer with a lower temperature. "Cold smoking"

# Biosecurity during Horse Events

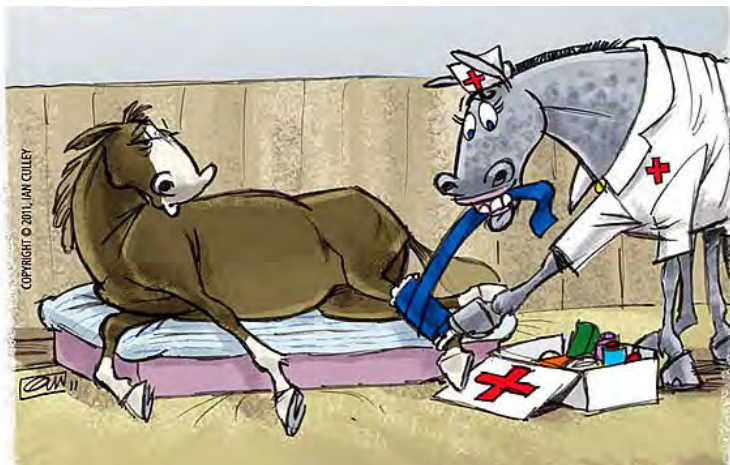
With the outbreak of Equine Herpesvirus-1 (EHV-1) myeloencephalopathy in May, biosecurity and showing horses have been front page news. Summer months are prime time for large, organized trail rides, horse shows, sales, parades, and other events where horses congregate. One show in Utah from which horses returned to multiple states illustrates very well how rapidly horses travel and can spread disease.

Following are biosecurity measures to implement when horses are congregated at events:

- \*Minimize nose-to-nose contact between horses. Do not allow another horse to sniff your horse's nose "to get acquainted".
- \*Do not share equipment for use with other people's horses. Alternatively, if any equipment is loaned, keep it away from your horses until it is cleaned with a detergent, rinsed, and properly disinfected.
- \*Do not use common water troughs. Bring your own water and feed buckets.
- \*Avoid common-use areas such as tack stalls used to groom and tack multiple horses. If these common area must be used, use cross ties instead of tying horses to a post, wall, or other nose-to-nose contact area.
- \*Halters, lead shanks, and face grooming towels should be used on one animal only and not shared between animals.
- \*Wash your hands or use a 62% ethyl alcohol hand gel before and after handling or riding other people's horses.
- \*Early detection of disease is paramount, especially contagious infections disease. Take horses' temperatures twice daily (morning and night) during the event and for two weeks after return to the stable.
- \*Quarantine horses when they return to the barn or training facility after an event.
- \*Clean and disinfect horse trailers before they're used by other horses.

These precautions do involve more work, more time, and more awareness. However, it will help reduce the risk of horses being exposed to multiple viral and bacterial diseases while on the road.

## President's Message

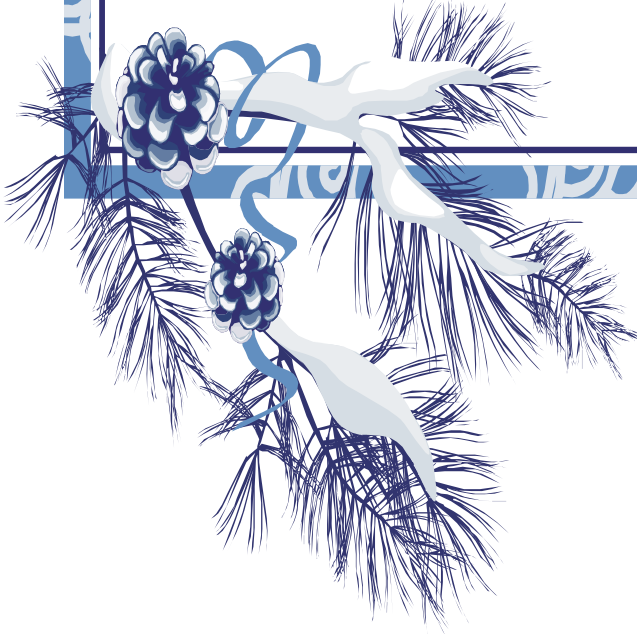
