## Pheasant Breast Wrapped in Bacon




4 slices of bacon

#### Nosework- What is it?

Nosework is a new sport for all dogs and their owners. It is structured so that all dogs, from the smallest to the largest, reactive or timid can be successful. Nosework is a natural for Vizsla's. But first, a little bit about how I became involved in Nosework.

We became involved with dog training, puppy class, obedience, agility, rally and hunt activities about 5 years ago with the arrival of our first Vizsla, Denver. We enjoyed all of this so much, we added a second Vizsla, Indy. About a year ago, our training club (NOCI) introduced a new class called Nosework. I really did not pay much attention until I heard one person say "if your dog is food motivated, nosework will be easy." This happened right after my agility class with Indy. I had been struggling getting Indy around any course because after every obstacle, Indy had to stop and make sure the dog before him did not leave a crumb of food behind. Food motivated? We joined the class and have been hooked ever since. I am now teaching 2 beginner classes at NOCI. I am also on the list to become a certified Nosework instructor. Indy and I continue in our nosework class at NOCI. Also, I could not be having all of this fun with Indy and not include Denver. When doing homework with Indy, I included Denver. As a result, Denver is easily keeping up with his little brothers nosework skills. Denver and I are now taking a nosework class at Four Your K9.

K9 Nose Work is the registered trademark of the National Association of Canine Scent Work, LLC. (NACSW $^{TM}$ ). I have borrowed a brief description from their website- <a href="http://k9nosework.com/">http://k9nosework.com/</a>

#### What is K9 Nose Work®?

Dogs have an amazing sense of smell and a natural desire to hunt. The activity and sport of K9 Nose Work<sup>®</sup> is designed to develop your dog's natural scenting abilities by using their desire to hunt and their love of toys, food and exercise. It's a great way for your dog to have fun, build confidence, and burn lots of mental and physical energy.



Initial classes use food or toys to develop the dog's natural hunting ability. After a period of time, scent is introduced to the dogs. It is paired with food or toys until the dog makes the association to the scent. During all of this time, the classes are introducing different environments to search and be comfortable with. When the dog becomes scent proficient, which can take anywhere from 6 to 12 months, you can begin competing if you choose to. Competition begins by registering both yourself and your dog with NACSW™. NACSW™ uses 3 different scents; birch, anise, and clove. The first obstacle is an Odor Recognition Test (ORT) for birch. The dog must indicate in 3 minutes or less which of 12 boxes, lined up in 2 rows of 6 and about 3 feet apart, has the birch scent inside. Passing this test is required before you can enter a Nose Work 1 Trial. In a NW1 trial, the dog must indicate where the birch is hidden in 4 different elements; container, vehicle, interior and exterior. A container search can have as many as 20 different boxes spread around a room is any pattern. In a vehicle search (exterior only), the dog must indicate where the birch is hidden on one of three vehicles. An interior search is usually done in an office or classroom. An exterior search is completed in a place that has both grass and hard surface areas. All 4 elements must be completed on the same day to obtain a NW1 title. Each new level adds an additional odor and more difficulty to obtain a NW2 and NW3 titles. Needless to say, Vizsla's take to nosework very easily. So if you are not a hunter or you just want a new activity to do with your dog, please consider a nosework class. I would be more than happy to help you discover how much fun nosework can be for you and your dog. So, if you have guestions or want more information, please feel free to contact me at

### Removing the Smell of a Skunk from Your Pet

#### Q. My pet got sprayed by a skunk. How can I get that smell out?

#### A. Cause

Contents of the anal glands of the skunk are sprayed onto the pet.

#### **General Information**

The scent of a skunk can not only be powerfully malodorous, but also very irritation to the eyes and mucus membranes. The secretions contain multiple chemicals. One group, the thiols, are responsible for most of the strong scent. Others are acetate derivatives of these thiols. They are responsible for the smell, that tends to linger and become worse if the pet becomes wet.

#### **Toxic Dose**

Not applicable

#### Signs

Of course, the most obvious sign is the smell. The pet may roll on the ground attempting to rid himself of the smell. The eyes may water, and the pet may be nauseated and retch.

#### **Immediate Action**

Either use a treatment specifically formulated for use on skunk odors like Skunk-Kleen of Skunk-Off, or use the following formula:

- \*1 quart 3% hydrogen peroxide
- \*1/4 cup baking sode (sodium bicarbonate)
- \*1 teaspoon liquid soap

This recipe can be doubled for bigger breeds.

Wet your pet down and work the mixture through the pet's hair. Leave it on for three to four minutes and rinse. The will generally need to be repeated several times. Be sure to throw away any excess mixture. Do NOT get any of the mixture in the eyes: as a precaution, place protective ophthalmic ointment in the eyes.

Note that the above mixture may bleach the hair color temporarily until the animal sheds and new hair grows in. Common antidotes line tomato juice, vinegar, or regular shampoos with not be as effective.

Remember, if your pet was close enough to get sprayed by a skunk, he also could have been bitten. Skunks may carry rabies. Examine your pet carefully

PET'S RABIES **VACCINATION STATUS** UP TO DATE.

Contact your veterinarian if the eyes are severely affected, of the pet continues to vomit or retch.

#### **Veterinary Care**

General treatment: Bathing with a special formula will continue, and the eyes will be flushed with water or sterile saline.

**Supportive treatment:** Medications may be administered to help with the nausea, if present.

Specific Treatment: None

Prognosis: Good

#### DOUBLE BUBBLE EVENT DESCRIPTIONS

BIRD PLANTING CONTEST FOR KIDS – Junior ages to 7 and may have parental help. Senior ages 8 and up. Kids will be given a live bird and instructed how to put the bird to sleep. The bird sleeping the longest is the winner. Trophy for both JR. and SR winners. Sign-Up at tent.

CAKE WALK – Dogs are walked in a circle and when the music stops must find a number to stand on. A number will be drawn and the winning number gets a prize. Done several times.

CALENDAR CONTEST - \$10 per photo entered. 4 votes for a single membership or a total of 8 per family. Votes are tallied by a committee of three. Highest vote getters will be in next year's calendar. Highest vote getter also gets 10% of the money collected.

LADIES POWDER PUFF DERBY – Ladies' event only. Ladies will be judged on how well they handle their dog in a field event for 15 minutes. Two birds planted per brace. Dogs will not be judged. Participants receive a special t-shirt. Limited number available, so sign up early. Trophy given to winner. Sign-up at tent.

LOCATE & POINT – Two handlers and their dogs are in the field at the same time and are timed on how fast they find and point a bird. Dogs must point. Dog with the highest score win a trophy – 4 winners based on Novice or Field Trial trained. Sign-up at tent. Cost \$5.00 to cover bird. Can enter multiple times.

OBSTACLE COURSE – A course with a variety of obstacles similar to agility competition. Participants can practice from 9 a.m. until 1:00 p.m. A timed run at 1:30 for winner. Novice and Advanced – two winners get trophy. FREE (a good way to see if your dog would like agility type competition)

PIGEON RACES – Pigeons will be in a container and you can place your bet on which pigeon will win. Pigeons will be released from the field and the first one to reach the top of the big brown barn is the winner. The pot is split between the winners with 10% going to the club. Someone will be selling chances or you can purchase chances at the sign-in table. Price \$1 per chance.

AGILITY SEMINAR – Learn about agility.

RUBBER DUCKIE RACE – Participants purchase a yellow rubber duck for the race down the stream. Time TBD, but after lunch. First duck to finish line splits pot with club. Sign up at tent and pick your lucky duck. \$5

WING & STRING – Two groups – pups 7 weeks to 3 months and then 3 months to 6 months are judged on how quickly and well they point the pheasant wing on a string. Trophy to both winners. Sign up at tent.

PUPPY TRAINING/GROOMING/OBEDIENCE – General puppy training, grooming, obedience, and types of AKC competition. Q and A to follow.

PIGEON PLOP CONTEST – Participants purchase a number on a board grid. Pigeon placed on board and where it poops is the winner. Chances \$1 each. Will be held two times.

RAFFLE – Items on table available for raffle. Tickets \$1 each. Winners drawn at 2:30 p.m.

LUNCH – A lunch of hot dog, chips, and misc. food left over from Saturday night dinner (until gone) will be available for purchae. \$3 Free soda and water all day.

VENDORS – There will be vendors available during the day with vizsla items for sale.
