From the desk of Phil Rosenberg -

Heat prostration is a summer hazard, a needless one caused only by owner neglect.

Dogs love to ride in cars, even if it's just down to the local shopping center, but remember, the cool of an early spring morning can heat up to a blistering midday sun. Dogs left in a car at nine can be literally baked to death by eleven. It only takes a few minutes for the steel trap that is your car to heat to a scorching 120 degrees even with the windows open an inch or more.

You should be aware of the dangers of overheating and take every precaution to protect your dog from a cruel and needless death.

1. Never leave your dog confined in a car in the sun.
2. If you have parked in the shade, remember that the earth moves, and the cool spot you chose may become a hot oven in a short time.

3. Check on your dog often.
4. Leave plenty of cool water available.
5. Leave windows to car wide open - an inch or two won't do. If you can't leave your dog in an open car - don't take your dog along.

Symptoms of heat stroke are excessive panting, agitation, frothing or frothing, rapid, shallow heartbeat and weak pulse. In advanced stages, the dog will collapse.

First Aid - Quickly immerse the dog in cold water until relief is given. Or lay dog flat and pour cold water over him, continue pouring cold water and fan him to evaporate water. If great quantity of water not available, cold towels pressed against abdomen and back of head aid in reducing temperature. Call a Veterinarian immediately!

Do not delay in getting treatment for heatstroke. It is a rapid killer.

They will speak on care of injuries in the field and they are also bringing along first aid kits that you can purchase, if you so desire. These Vets are really great, so DON'T MISS THIS MEETING!

 A board meeting was held after our bi-monthly meeting March 16th.

All members of the board were present. After much thought and discussion the Board of Directors decided to have the Vizsla Club of Illinois, Inc. Hall of Fame with the following rules:

1. A dog can be nominated by any member of the V.C.O.I. at a regular meeting of the V.C.O.I. Nomination must have a second. The dogs names are then presented to the Board.
2. One dog will be chosen each year.
3. Nominate above average dogs only.
4. The dog has to be deceased, or retired for at least 2 years and be at least 10 years old if retired.
5. The owner's permission has to be obtained before nominating their dog.
6. The owner of the dog must have had at least a years membership in the V.C.O.I. to participate.
7. A suitable award will be awarded at the Christmas party.
8. Dogs resumes will be kept on file with the secretary to resubmit the next year.....

We will start with the 1st nomination: at the May meeting, July the 2nd nomination, etc..Resume has to be in the hands of the Secretary no later than September, 1977.

John Ewers volunteered to place an ad in the Tribune every mth. John will work with committee chairmen, in case there isn't an event that month we will have a club ad. The club will rotate board members in each ad using their name and phone number..... Mike Florian volunteered to make a new wall plaque for the V.C.O.I. hunting dog awards..Meeting adjourned.....

***** V.C.O.I. FUN TRIAL *****
 COMING - MAY 22nd, 1977

When other Vizsla Owners around the country ask me why our club dogs are so good, I mention the fact that we hold many Fun Trials throughout the year and, therefore, our dogs are never out of shape or out of practice.

So---here is another chance to keep in shape, stay in practice, and have a great time with the whole family. On May 22nd, we will have a fun trial somewhere near the Busch Farm. The fields have all been planted at Busch's, so to keep peace and preserve the use of the old grounds for the future, a new ground is being sought for this fun trial.

REMEMBER THAT DATE - MARK IT ON YOUR CALENDAR - PLANT TO ATTEND..

There will be 5 events (stakes) at this Fun Trial:

1. Young dogs (under 2 yrs) Not Field Trial Trained (retrieve-optional)
2. Older dogs (over 2 years) Not Field Trial Trained (Must retrieve)
3. Young dogs (under 2 yrs) Field Trial Trained. (retrieve optional)
4. Older Dogs (over 2 yrs) Field Trial trained (Retrieve required)
5. JUNIOR Handler. Handler 15 yrs old or less.
 Handler judged - Not dog.
 Handicapped by age.

A Field trial trained dog is defined as:

- a. a dog who competes or has competed in an AKC Field Trial or an American Field Field Trial, or
- b. is owned by or is handled by a person who competes or has competed in an AKC or FDSB Field Trial in the last two years.

All dogs in all events will be judged not only against one another, but also against that level of training and age that the owner/handler claims for that dog prior to running. The optional retrieve for younger dogs is to allow them to qualify for the certified Hunting Dog Award.

The Not Field Trial trained events are open to Vizslas Only The Field Trial trained events and the Jr. Handler event will be open to any Vizslas and members' dogs.

You will receive an additional flyer in the mail as soon as the location of the grounds and final plans are completed. Meantime, save the date - May 22, 1977 and make plans for the whole family to attend for the whole day.

VIZSLA CLUB OF ILLINOIS FIELD TRIAL JUGGERNAUT ON THE ROLL!:

With the Fun Trial, Hairy-chested Men's Invitational, and a few field trials under their belt as a warm up, the VCOI Field Trialers entered the final weeks of the season with unprecedented strength and confidence. Like hungry snakes looking for anything warm at which to strike, they moved into Ohio to begin a winning binge that was not to end until four weeks later.

At the Vizsla Club of Greater Cleveland Field Trial at Killdeer Plains, DCh. "Rippi" (o/h Ken Crago) scooped up 1st place in the Open Ltd. Gun Dog and 2nd in the Open Gun Dog (1st went to an Illinois bred dog). The Amateur Gun Dog stake saw two Illinois dogs score for the first time. Apollo (o/h Jim Busch) was first with a heart-stopping, eye-popping half hour that featured two back course finds, three in the bird field and a 50 yard back; Amber N Dukas Arocep Flame, just 10 weeks after having a litter won 4th place with a brilliant back course and one immaculate find and retrieve in the bird field. Many other placements at this trial went to dogs either bred in Illinois or out of dogs bred in Illinois. The following weekend at the Miami Valley Vizsla Club Field Trial held at Cherrybend Pheasant Farm the Vizsla Club of Illinois put on a display of winning power that was almost obscene. In the Open Ltd. Gun Dog Stake, DCh. "Bing Bang" (o/h Jim Busch) was first, DCh. "Rippi" (o/h Ken Crago) was second, and D.Ch. & Nat. Ch. "Willie" (o/h Tony Lucas) was third. Only an eye lash separated these three dogs each having multiple finds and far flung hard driving courses in this "gunner handler on the course" stake. Driving rains made this stake and others run on Saturday a severe test of man and dog. In the Derby, Spring Creek Express (o/ Roger Paluska h; Gerry Paluska) placed first, littermate Spring Creek Edition (o/h Gerry Paluska) placed second, and Brook's Red Alert (o/h Tony Lucas) placed third. In the Open Gun Dog, DCh. & Nat. Ch. "Willie" was first, DCh. "Rippi" was second and DCh. "Bing-Bang" was thrd. Fourth to "Dandy", and an Illinois bred dog. In the puppy, Spring Creek Express was first, second to "Buck" o/h Darrell Cunningham, (Darlan's Sunset Buck) and 4th to "Misty" an Ill. bred dog.

An interesting sideline to this trial was that 1st, & 2nd were withheld in the Amateur Gun and 1st was withheld in the Amateur Limited Gun Dog (Illinois dogs did not enter this Ama. Ltd. stake). It was almost as though if first could not be won by VCOI then no one could win it. Also, please take note -- the Cherrybend Pheasant Farm is probably the best Field Trial venue in Ohio - in spite of torrential rains on Saturday, the footing for dog, man, and horse remained excellent throughout the trial. All dogs showed well bothdays and handlers did not require hip boots & boats like they needed at Killdeer Plains that same weekend. Everyone wants to win, but if you can't, you want to at least look good while losing.

The next weekend the scene moves to Iowa for The Vizsla Club of Eastern Iowa Field Trial at the always excellent Hawkeye Wildlife Refuge. In the Open Limited Gun Dog, DCh. "Rippi" took second, and Apollo took fourth. In the Puppy, Spring Creek Express took first and Darlan's Sunset Buck (o/ D.Cunningham h/J.Busch) took second. Third went to Willie's Russet Duke (o/ C.Boegel h/ Tony Lucas) and fourth (winning her first ribbon at six months + 3 days) went to Passes Crazy Cory (o/h Vern Fasse).

And, concluding this 4 weekend binge of winny by the V.C.O.I., was the German Wirehaired Pointer Club of Illinois trial held at the Des Plaines Wildlife Area. In the Am. Ltd. Gun Dog, DCh. "Willie" placed second, Apollo third and D.Ch. "Rippi" placed fourth. In the Open Gun Dog, Apollo placed third and Beau James Frost (GSP) O/H P. Rosenberg, placed fourth. In the Open Ltd. Gun Dog., DCh. "Bing Bang" placed fourth. In the puppy, Honorable Mention went to Spring Creek Express and Willie's Russet Duke. In the Derby, Willie's Bushwak "Barney" McGee (o/h Mike Florian) took fourth.

The power, talent, and depth exhibited by the VCOI at these trials is awesome. It almost appears that if you want to be a winner within our breed, you'd better join the VCOI or at least buy an Illinois bred dog. What is even more exciting is the fact that there are several more talented Illinois Vizslas that are poised on the brink of winning ways - Golden "Britta" of Bartlett (o/h Mike Florian) and Ch. Brookwood's "Roc O" Dez-Tsindee (o/h Pete Ingrassia); are broke and in shape and only need field trial experience to climb on that winning juggernaut that is the VIZSLA CLUB OF ILLINOIS FIELD TRIAL TEAM.

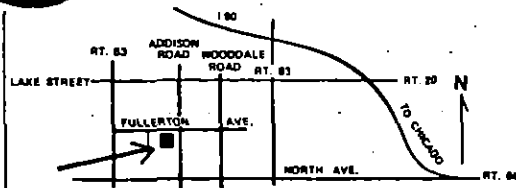
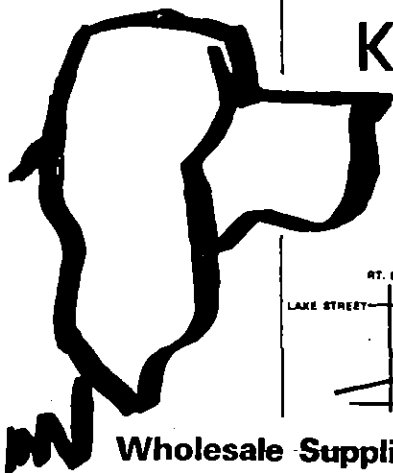

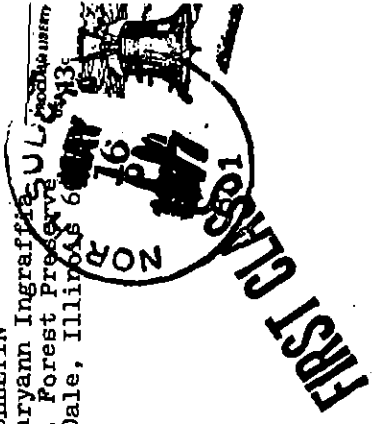
