Not make false or misleading statements about the dogs or character of any member who meets the standards of the AKC's Code of Sportsmanship.

Respect the history, traditions and integrity of the sport of purebred dogs.

Commit ourselves to the values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.

We should welcome, encourage and support newcomers to the sport.

Always consider as paramount the welfare of our dogs.

Any kind of abuse to a dog or person will not be tolerated at a VCOI event.

Each member should be aware at all times that the VCOI exists to protect the breed.

Each member shall at all times display good sportsmanship and conduct. Whether at home, traveling, at shows or motels they will treat all present, including competitors, judges, officials and spectators with respect and courtesy.

Each member must accept the responsibility to protect the interests of our breed by conducting himself in a manner designed to reflect credit on himself, the Vizsla breed, and the Vizsla Club of Illinois.

#### Spring can be Dangerous to Dogs!

Spring is the time of the year humans start sprucing up the yard and flower beds. One of the more common mulches used is cocoa mulch. Cocoa mulch can be lethal to dogs if too much is eaten. Cocoa mulch contains a chemical known as Theo bromine which is the same thing that makes chocolate poisonous for dogs. It has an attractive smell and taste for dogs. Eaten in small amounts it may cause gastrointestinal distress. Eaten in larger quantities it can cause tachycardia, muscle tremors, seizures, and even death. Other signs are vomiting, diarrhea, lack of appetite, depression, and hyper-excitability. Other potential exposures include pesticides and mycotoxinproducing mold.

If you notice your dog eating cocoa mulch, induce vomiting. If it is much later and symptoms are present, you must get to a vet immediately.

Another deadly ingested item is mushrooms. Some of those growing in your yard may be toxic and fatal. Some can become ill by just licking a poisonous mushroom. Some are even allergic to edible, normally safe mushrooms. Symptoms can range from mild vomiting and diarrhea to severe digestive problems to complete liver failure. Be cautious of parasol-shaped mushrooms and all small brown mushrooms. New mushrooms can appear overnight. If you see mushrooms in your yard or where you walk your dog, dig them up. Smashing or kicking them spreads the spores and even more will grow.

Toads are another danger as they can secret a substance that can irritate a dog's eyes or tongue. Catching and chewing a toad can cause excessive salivation and sometimes disorientation. If your dog catches a toad, flush his mouth with water and point the dog's head downward so he does not swallow. Some toads are deadly, however. Drooling, head shaking, pawing at the mouth, crying, and attempting to vomit are some symptoms that a dog has had contact with a toad. Symptoms of toad poisoning in dogs can include heavy drooling, head-shaking, vomiting, diarrhea, bright red gums, weakness, loss of coordination, fever, irregular heartbeat, difficulty breathing, tightly clamped jaws, convulsions, and even death.

If you need to induce vomiting in a dog, you can use Syrup of ipecac (1 teaspoonful per 10 lbs of weight, or Hydrogen Peroxide 3% - 1 tablespoon every 10 minutes and repeat 3 times.

If you are not sure what to do, call your veterinarian immediately or the ASPCA Animal Poison Control Center at 1-888-426-4435.

# National Titles & Placements for VCOI Members

#### **Burr Oak's Old Number Seven wins 2010 NGDC**

This year's NGDC was held at the Stockton Plantation, just outside of Newington, Georgia. Thirty seven dogs were entered in the championship including the winners of the last three National Gun Dog Championships and many from the VCA Amateur and Open Top Ten Lists.



Jack finished his FC and AFC in 2008, placing 2<sup>nd</sup> in the NAFC in Sonata, Arizona in November 2008. Jack made the second series in both the NFC and NAFC last fall in Danville, Virginia but did not place. Perhaps he had Georgia on his mind.

There are only 3 National Championship titles awarded each year by the AKC for VCA events. To capture one in a lifetime is a great joy. So many great dogs come close but never quite have all the needed elements line up when they run. Jack had a great day in Georgia, running in the ninth brace on the second day of the trial. One thing both Brian and I came away with from this event was the different between a 30 minute stake and a 60

minute stake. Many dogs looked great at 30, but faded badly over the second 30 minutes. A second observation was that bird work is very important and if you want to win, it had better be flawless, Jack's was. Jack's win was a high point in my 27 years of field trialing. I have come close before, but not until this year and Jack's winning performance was a national title awarded to a Burr Oak Vizsla.

No one achieves a national title by themselves, it is such a difficult journey that without the support of fellow competitors and club members you would never last. Jim Busch helped me start the journey and picked me up more times than I can count. He also knew how to challenge my competitive spirit when things got tough. Many others helped along the way pointing out with great vigor my handling and training short comings. Yes, they helped me also, but not without a big dose of pain.

I have had three great wins in my Vizsla career, beginning in 1985 when Princess Molly won the Midwest Futurity. She was my first Vizsla as you can probably tell by her name. The second win was in 1993 when Bo Knows Birds captured the Derby Classic at the Nationals in Ohio. Bo placed over 70 times in his 6 year career which was cut short by the requirements of my day job. Bo came close but not until many years later did Jack finish the deal. To say I am satisfied would not be true, but to say I will always appreciate the win in Georgia would be right on. Every time I fill out an entry for NGDC FC AFC Burr Oak's Old Number Seven I will enjoy the experience all over again.

Thank you to all my friends and fellow field trialers who helped me stay the course over these many years.
