
Got a note from Chris Welker indicating she has an eightmonth old puppy bitch available if anyone knows of someone

DOUBLE BUBBLE WEEKEND

Mark your calendar July 22nd and 23rd as the weekend of the Specialty & Fun Trial. This year the weekend has gotten bigger and better. We will also be holding a Junior Hunting Test on Saturday just after the Vizsla judging at the fairgrounds.

As usual, the festivities will begin on Friday night as the Vizslaphiles from all over the country will begin to assemble at the Busch farmette. A few drinks will be shared, stories will be swapped, brags exchanged, and preparations made for the next two days.

There is plenty of camping space here and plenty of bedroll room inside the house. Some years it's cool, most years it is hot. We are not air-conditioned, but you are welcome. There is a new motel in Belvidere just around the corner from the fairgrounds where the specialty will be held. It is the Oxford Inn (815) 544-7111, If you get a room there, we may join you for the night - it's got air!

The Vizslas will show about 10:00-10:30 a.m. We are usually out of the ring before noon. There will be some liquid refreshment at the VCOI enclave at the fairgrounds. There will be a luncheon under the shade trees at the Busch farmette starting about 1:00 p.m. A small donation is requested to cover expenses.

Backing up a bit - at 10:30 the Junion Hunting Test will begin at the Busch farmette. We plan to take entries sufficient to run until 8:30 p.m. For those of you who are entered in the Specialty, if you'll include a note with your Hunting Dog entries, we will see that you are not required to be in two places at once.

The Group judging begins at about 3:00 p.m. We will have a spotter at the fairgrounds who will call to alert us to "get back" to the fairgrounds (from the Busch farmette) for Group judging. We usually field a clique of about 100 to boost the Vizslas BOB into a Group I or II. We've been successful the last five years! The Hunting Test will keep perking along unless we have a short entry, in which case, we will take a break during Group.

I have heard that as of June 24th we have 35 entries in the Hunting test. If you hurry, you still have time to call an entry or two in to Roy Greffin at phone # 312-587-7299.

Saturday P.M. the party lamp will again be lit. Things break up fairly early though. Everyone is tired from Saturday and getting ready for Sunday - FUN TRIAL '89.

We will begin about 8:30 a.m. and run until done. We usually begin with *Field Trial Young Dogs - dogs under 2 years, belonging to anyone. This event is primarily for field trialers, but non-field trialers often put their young dogs in to test them against the best. This event frequently has a large entry and gives us time to get everyone signed up for the rest of the day's events.

Illness has struck the pigeon flock, so while we have enough for the races, we do not have enough for the bird planting contest or Junior Handler. We will use quail instead. The six regular field events (*) will be \$7.00. Junior Handler and Bird Planting Contests will be \$3.00 each. Obstacle course and Wing & String are free.

The VCOI will supply soft drinks and beer for all events everyday. Luncheon will be provided for a small donation on Saturday. Sunday bring your own picnic lunch. (Kentucky Fried and McDonalds, etc. are nearby if you forget)

During the Fun Trial, dogs that fulfill the requirements can earn, in addition to placements, the coveted VCOI Certified Hunting Dog Award. You will receive the parchment certificate, suitable for framing, and your dog's name will be inscribed upon the perpetual plaque that hangs in the meeting room.

Also, for that dog that gives the best performance in relation to the ideal for the event that he has entered, the Dog of the Day award is presented.

If you have been to a Double Bubble weekend, you'll be back this year because short of the Nationals, there is nothing like it anywhere in the country. If you have never been, now is the time, Boone County is the place!!! If you need information, call Jim or Linda Busch at (815) 765-2934.


