HEARTWORM IN DOGS - By J.D. Jobe, D.V.M.

Heartworm is a dog disease which is characterized by 1 to 300 white worms 6-12 inches long which lodge in the right chamber of the heart and interfere with blood circulation.

The symptoms of the dog would be similar to a human victimized with heart disease. There are two forms of the heartworm in the dog's circulatory system. The adult form was described above. The immature form is microscopic in size and is called a microfilaria.

Heartworm is a disease which is transmitted by the mosquito. The mosquito sucks blood, which contains microfilaria, from a heartworm infected dog. At a later date, the mosquito injects the microfilaria into another dog.

During the next six to eight months, the microfilaria migrates to the right ventricle of the heart where it matures. At this time, the adults start liberating their offspring microfilaria into the circulating blood, where they may be picked up by another mosquito.

This disease is diagnosed by a blood test and the infected dogs may be treated by the use of two drugs. The treatment can present a certain element of risk, particulary in the dog which is showing symptoms. A pre-treatment physical and laboratory examination will help the veterinarian evaluate the possibility of these risks.

Early diagnosis and treatment is medically recommended. During the past few years, a preventative treatment has been developed which is administered daily one month prior to the mosquito season until two months after the mosquito season.

Heartworm is rather common in the southern parts of the United States. The disease has been present in the Chicago suburban areas for about 10 years, and all indications are that the disease will get

more prevelant every year. We recommend that all dogs living in mosquito infested areas be tested annually.

Dogs that are around creeks, ponds, rivers, and stagnant water areas are most susceptible to the disease. Also persons vacationing in the South with their pets should take precautionary measures.

Dogs in Southern Illinois are probably about 3-5 times more susceptible than dogs in the Chicago areas. It is estimated that about 6% of the dogs in the Downers Grove area have heartworm disease.

There are at least three different methods used for testing heartworm disease. The direct smear method which is the easiest, fastest, and least costly of the three tests is also the least accurate method - about 85% accurate. The Modified Knott's method is the recommended test at the present time and is about 97% accurate.

Heartworm may be prevented by giving oral medication to your day daily from the beginning of mosquito season until two months after the mosquito season.

It is not safe to put your dog on this medication if he has detectable microfilaria (young worms) in the blood. Thus the dog must be checked before being placed on this program. The oral preventative medication acts on the young worms shortly after they are introduced.

It will not destroy either the adult worms or the partially developed worms in the heart. The worms require about six months or more to mature and produce the microfilaria (young worms) which can be detected in the blood.

For your dogs safety and protection he must be checked before starting on the daily oral preventative medication and again in three and six months after starting the medication.

It may be necessary to interrupt the program to treat a dog for the adult worms which have developed from prior exposure.

### PREVENTATIVE PROGRAM

- 1. Have the dog checked for heartworm.
- 2. The preventative drug must be given as prescribed daily.

- 3. Since the effective dose of the drug is determined by the weight of the dog, any significant change in the dogs weight must be reported to us so adjustments may be made.
- 4. Any unusual behavior by your dog, such as vomiting, must be reported immediately.
- 5. It is necessary to have the dog checked for heartworm three and six months after starting the medication.

\* HE OUGHT TO HAVE HIS MIND ON HUPTING \*

My most important theory on using a Field Trial dog at stud is that I want him to have me on his mind - just me and business, it isn't quite as important with regular trial dogs, but I do not breed my national caliber dogs from July 1 until the Nationals are over around November 1. That way they have nothing on their mind, but me and the job they have to do. I imagine the big Pointer people do the same thing because I see their ads which specify the stud fee - "when not being campaigned."

A lot of people oreed their dogs at a trial or in the back yard or in the back of a pick-up or horse trailer. Consequently, wherever the old dog goes he has girl friends on his mind. Then they take their dog to the line, the first thing the old dog does after cast off is a quick check on his bracemate. When you come to the line, it's for business and not that kind of business. That really irritates me to see that happen.

I have one certain kennel at my place where all the breeding is done. The only time a dog goes to that place is when there is a bitch to breed. Because of this, you'll never see one of my dogs checking out another dog at a trial. They know they are there to find birds and not a dog in heat.

I don't care whose bitch it is, I will not breed her to one of my dogs at a trial. If they want to ship the dog to my kennel, I'll get her bred. But I won't have anything to do with breeding a bitch while I'm on the road at a trial or anywhere else.

When people send a bitch to my kennel, I like to have her three or four days before she is ready to be bred so she has a chance to settle down. Even though a bitch is ready to accept a dog, sometimes they are tense and won't stand. I like to breed them twice - on the 10th day and the 12th day, or the 11th and 13th day. It depends on the individual. Some of them won't breed until the 15th or 16th day.

If a bitch is in my kennel for three days to a week, I don't charge any board, but if I have to keep them longer, I have to charge some board. Some people charge board for just one day, but I figure that is just part of the stud fee.


When it comes to the actually breeding, I see many people just turn them loose. Curs might do it that way, but I hold the bitch to make sure she can't bite the stud dog or flip around real quick. It just takes one case like that to ruin a valuable stud dog. People say, "Why don't you turn them loose and let them have fun?" Well nobody is interested in letting them have fun, I hold them because it's a business and I have to protect my stud dog. Some people will send me a bitch that isn't worth the hind leg of a national champion and it doesn't take but just a little longer to do it right.

Some people won't use their stud dog, but every other day. I've never been faced with having to breed any more than that. It's been said that the more a stud dog is used, the more fertile he is and that if he will cover a bitch, it doesn't make any difference if its once a month or once a day.

I always require the stud fee at the time of the stud service and if the bitch doesn't conceive, I give a return service. There has to be a stopping place somewhere and the general rule is one return service.

One way to keep teenagers out of hot water, is to put dishes in it.
