## VIZSLA CLUB OF ILLINOIS FALL FIELD TRIAL by Chairman, Jim Busch

The weekend of September 11-12 was such a spectacular success at the Des Plaines Wildlife Area for the VCOI that you must bear with me while I attempt to wax eloquently. The five stake program included Open Derby and Amateur Gun Dog for Vizslas only. stake had 17 entries. The Open Gun Dog, Open Ltd. Gun Dog, and Open Puppy were for all Continental pointing breeds and they all showed up! We ran in the three open stakes 26 Vizslas, 12 GSP's, 8 GWP's, 5 Irish Setters, 2 Brittanys, 2 Weimaraners, and one Gordon Setter (and a Partrudge in a pear tree). Every breed had a Field Champion entered except the GWP's and the Brittanys. If you include Honorable Mentions, every breed placed except the Gordon (a 9 year of F.Ch.), and the Britts (one pup and one 20 mo. old gun dog) Of the three placements given in the Amateur Gun Dog, one went to Piri, an Ohio dog, one to an Illinois Vizsla, and one to an Iowa Vizsla. In the Derby, Cline\*s Roguette Blitz blitzed them all by winning lst and this in the last brace and hottest temperatures of the stake. Agin the ribbons were spread between 3 states, lst, 3rd, and H.M. to Iowa, 2nd and 4th to Illinois, and H.M. to Ohio. In the 22 dog all breed Puppy Stake, an Illinois Vizla placed 3rd, and an Ohio Vizsla placed 4th...truly outstanding accomplishments. The 14 dog Ltd. Gun Dog was a mini championship, i.e., a 1/2 hr 1st series on continuous courses, while all braces ran over the same 250 acres, no brace was run exactly over the same course as any other. The heat mitigated against any definitive bird work during the first series and the judges were free to call back any and all placeable dogs for the second series of a short back course and a full eight minute bird field with gunner handler. Seven dogs were called back, 2 Vizslas, 2 GSPs, 1 Irish, 1 Weim, l GWP. Only 2 dogs were lost in the second series and VCOA Nat. F.Ch. of 76 Dual Ch.Am.F.Ch. Brooks Willie Whompum walked away with top honors. Dual Ch. & Am.F.Ch. Jodi's Jump-N-Bing Bang Bucz garnered 3rd in this stake.
On Sunday the 20 dog single course with bird field and official guns Open Gun Dog stake ran. At the conclusion of the stake. the judges commented that they had 11 clean dogs and six of eleven could have placed 1st anywhere any time. Dual and Am.F.Ch. Jodi's Jump N BingBang Bucz topped the field with i cerebral course of hugh proportions and flawless bird work. is out-on-the-limb styled find of a pair of pheasants impressed even his owner, me, Jim Busch, who should be used to his doing amazing things. And just tokeep it in the family, Bing\*s half brother, Dual & Ama, F.Ch. Rippi of Webster Woodlands running also a cerebral course featuring an out-on-the-lumb find placed third. I must mention that Rippi finished hs 1/2 hour in the Ama. Gun Dog on Sat. on three legs. Keith Crago, Ken's son and a fierce competitor, got up early Sunday and massaged Rippi's leg for two hours to remove the stiffness. Hoof bed and made him bring Rippi to the trial. He then got Ken out Special thanks to all who worked to make the VCOI fall trial a success. Our gunners Tim Stapleton and Jim Valukas are greatonly one missed bird all day. Look for Jim in the trials in the future for he is already building a kennel for his little Judy B & Bing Banger pup. Young JimmyBusch, Keith Crago, John Busch, plus many adults planted birds for two days and at best it is a thankless task. In the heat we endured all weekend it's torture.

The Illinois Animal Welfare Act makes anyone who owns or
harbors more than five breeding females a kennel operator. It
matters not whether the dogs were bred ever or never, only that
a person owns them.

In the past, responsible dog owners, people who maintained their dogs well and were not a nuisance, remained hidden from such laws. The point must be emphasized that the ADCA is not only not opposed to regulation, but favors it. However, most ordinances and laws do not differentiate between the hobbyist and the commercial operator and place the hobbyist in conflict with his zoning laws and that is the problem.

Unfortunately, the days of dog people remaining hidden may be about over and defense of the right to own dogs is becoming increasingly important. There occured recently a situation involving a request by Illinois, for AKC records pertaining to dog ownership in that state. Certain information was made available to the State of Illinois by the AKC. Further, the ADOA is aware of other planned requests for such information.

As a result, the ADOA held discussions of the this matter with the AKC. It is interesting to note that ADOA attorneys believe the section of the Illinois law under which the request was made, prohibited the request as it was made. In other words our attorneys are of the opinion that the AKC could have simply said "no". But, also unfortunately, apparently the AKC did not subject the Illinois law to legal review to determine the necessity to comply.

However, this situation clearly emphasizes the necessity to look very carefully at the legal aspects and details of each and every such case. No longer will opinion or non-legal logic prevail. No longer can we depend upon the seeming rightness of position as dog owners. It's down to the nitty-gritty where highly sophisticated legal arguments of a constitutional nature must be presented and argued, and this must be done by the most competent people available.

The ADOA should have already pursued a Federal court case in this area. Unfortunately, resources necessary were not available.

It is planned to initiate such action shortly.

First of all I would like to say I always enjoy your Bulletin. Second, I was quite surprised to read that one of your members had his dog's ear tattooed for identification purposes. any one aware of the newer and far more permanent way to tattoo? An ear can be cut off and the dog sold to a research lab or to a hunter.....Dog had bad accident, sir! I've been doing the tattooing in connection with the National Dog Registry for 2 years and I've done about 70 dogs from the size of a Maltese to an Irish Wolfhound. Some of the dogs had to be tranquilized slightly, but that sall. Some Vets will tell people that it is so painful that the dogs have to be put under completely. The owners Social Security No. is but on the inner right flank with an electric needle that slightly scratches the skin. That in turn can be sent to the (recorded) National Dog Registry, which has a 24 hour answering service.. Nationwide ... . For more information: Dagmar S. Swanson, R.D. 1 Box 227, Carmel, New York 10512. (Marlene tells us she had a puppy bitch out of her Zsa Zsa that has been doing some winning with . . Good going, Marlene.) I sincerely hope that your club will look into the tattooing. I got Zsa Zsa back through this. She was gone for 4 days. The people that had her thought she was a nice big, brown dog. 451bs, 22". Injuries prevented them from seeing the tattoo. When they read my Ad and checked they called me immediately. There was "ONE BIG REUNION" I shall never forget and hope I never have to have again. This was really one of the most agonizing experiences I've ever had. Good luck to you all,

Oregon opened the first season in 1891. The 21 pheasant released a decade earlier must have been the world's sexiest game birds because that first harvest was estimated at 50,000 ringnecks. In short order a number of other states, from Utah and Idaho to Massachusetts, New York and New Hampshire, established pheasant populations for their hunters.

Again according to the Midwst Pheasant Council, the yearly take averages 12-million birds. (Which means that in terms of pheasant hunting alone, sportsmen pump \$216 million a year into the nations economy.)

Hi! Thank you for your request for information about NAVHDA. We have had many gratifying letters from hunters all over the Wisconsin and Northern Illinois area who want to know more about NAVHDA. Our local group, the Wisconsin Chapter, has training sessions with our dogs, informative meetings, sanctioned NAVHDA trials, and just plain dog talk. We meet one weekend a month.

NAVHDA is a non-profit organization whose purpose is to foster. improve, and promote the versatile hunting dog breeds in North America. It does this by sponsoring field tests for the versatile breeds that truly test their versatility, and by offering training clinics.

fering training clinics.

NAVHDA sanctioned tests are open to all hunting dogs registered (or eligible for registration) with a recognized kennel club or breed club. This includes Brittany Spaniels, German Shorthair Pointers, German Wirehair Pointers, Griffons, Pudelpointers, VIZSLAS, Weimaraners, and others.

The Natural Ability test is for dogs 16 months and under. It covers seven different hereditary characteristics which should disclose the latent natural abilities that are required to develop the specimen into a versatile hunting dog. These 7 characteristics are: nose, search, water work, pointing, tracking, desire to work and cooperation.

ing, desire to work and cooperation.
The dogs are tested individually in the field for not less than 20 minutes over a random course on native or liberated birds.
This test dertermines pointing instinct, search pattern and scenting ability. All dogs are given a test for gunshyness.
This takes place during the search. A gun of conventional guage is fired twice by the gunner. No birds are shot over the dogs in this test.

For the water work, a dummy is thrown into deep water and the dog must enter the water and show no fear or dislike of cold water. No retrieve is required.

Each dog is also given a tracking test with a live pheasant. The dog must display eagerness and perseverance on a track. The dog may point or retrieve, just so he follows the track. An intelligent dog knows when to lower his head to follow the track of a cripple, and when to use air currents for body scent.

Another function of NAVHDA is to help owners of versatile huntting dogs enjoy their dog more, through proper training. One day training clinics are held in conjunction with sanctioned NAVHDA trials. Whoa, retrieving, water work and tracing are covered. Clinics are open to dogs of any age.

The test itself, as well as the individual tests, simulate, as nearly as possible, actual hunting conditions. Details of each test and scoring method are in the NAYHDA Field Test Standards booklet, which containes not only descriptions of each test, but also pictures and diagrams, plus a history of the versatile hunting dog breeds. Tom Novinska R.R. 1, Box 18A Fennimore, Wi. 53809 Excessive aggressiveness or shyness, chewing and biting, barking, house soiling, digging, and general disobedience are common complaints among dog owners. To the point where, "This dog has to go....."

Although these problems can't always be predicted when a dog is young, there are certain behavior characteristics a prospective dog owner should consider when selecting a puppy, says William Campbell, a California animal behaviorist. He recommends a few puppy hehavior tests.

An aggressive pup, as determined by these tests, is often unsuitable for homes with small children or senior citizens. If it's in a calm adult household and trained by nonphysical teaching methods, it, however, may become a fine pet capable of agressive protective actions.

Independent pups that show no social attraction, no following response, and walk away during the social dominance test often interact poorly with children. Also, they may not socialize, quickly and may be difficult to train. Those with a positive social attraction follow responses without aggression and tolerate restraint. Social and elevation dominance fits well in most environments.

But finally, before going on to the test, it must be remembered that any dog may become a behavior problem if it is not favored by all household members or is subjected to an inconsistent environment and confusing or irregular training methods. However, a dog selected for specific behavioral tendencies has a better opportunity to become a loved and respected member of the family.

It is best to select a 6 to 8 week old animal, and to consider the size and health of the puppy and the reputation of the seller Take the puppy to an isolated area, relatively free from distraction. Gently place the pup in the center of the room or space and move several steps away in the opposite direction. Kneel and gently clap your hands. How readily (if at all) the little guy comes to you, Campbell, says, tail up or down reveals its degree of social attraction, confidence or independence.

Next, stand beside the pup and then walt away. How well it follows reveals its degree of following attractions. If you are sure the puppy sees you walk away, failure to follow indecates independence. And biting at your ankles may indicate agressiveness.

Another test is to gently roll the pup onto its back and hold one hand on its chest for 30 seconds. How well it accepts or rejects your dominance indicates its degree of submissive of dominant tendencies.

Now gently stroke the puppy from the top of its head downward along the neck and back to see if it accepts or rejects your social dominance.

Cut pheasant into serving pieces and pat dry with paper towels. In a saucepan combine the giblets, excluding the liver, 1 carrot and 1 stalk of celery, both halved, 1 onion, and a bouquet composed of 3 sprigs of thyme, parsley, and 1 small bay leaf and add chicken stock of broth to cover. Simmer, skimming froth as it rises, for 1 hour. Strain and reserve.

Sprinkle pheasant with salt and pepper. Brown in 3 tablespoons bacon fat over high heat and transfer to casserole. Add 1 cup unpasteurized apple cider to the skillet and cook the liquid over high heat, stirring in the brown bits clinging to the bottom and sides of the pan, until it is reduced to ½ cup. Stir in 1 cup of reserved stock, bring liquid to a boil and pour it over pheasant. Braise pheasant covered in a preheated 325°F oven for 1 hour and 15 mins., or until it is tender. Transfer pheasant to heated serving dish. Stir 1 teas. arrowroot mixed with 1 tbl. cold water into the pan juices and cook the sauce, stirring until smooth and thick. Add salt, pepper to taste, pour over pheasant. Serves 3 or 4.

### PHEASANT WITH SOUR CREAM

Cut pheasant in pieces as for fired chicken; Shake pieces a few at a time with seasoned flour (salt, pepper and paprika) in a brown bag. Brown pieces slowly in one-half cup hot fat, turning only once. As pieces are browned, remove to roaster or

casserole.
Over the pheasant, sprinkle 1 finely chopped apple, one-third


cup minced celery and a small onion, chopped fine.
Pour from the skillet all but 1 tablespoon of fat. Add 1 tablespoon of flour to the fat in the skillet and stir well over heat. Stir in 1 cup sour cream and 1 cup dry white table wine or water. Season with salt and pepper.

Pour sour cream mixture over browned pheasant. Cover and bake slowly at 300 or 325 degrees for one to one and one-half hours or until tender.


