#### SECRETARY REPORT

The meeting was called to order at 7:45 p.m. by president Wanda Berner at the Pine Grove Restaurant in Rosemont, Illinois. 14 people were in attendance.

President stated there was no Board meeting, so nothing to report there. Minutes from the last meeting were accepted. Wanda thanked Linda for the new membership directory with the color cover, and she also thanked Jeff Parise and Cathy Gallagher who did a great job of running the Hunt Test in September.

**Secretary's Report:** No mail has come in, so nothing new to report.

**Treasurer's Report** – Treasurer reported a favorable bank balance.

#### **Committee Reports:**

June Hunt Test – Motion made and passed to take back our second day of hunt test activities formerly with the Brittany club and turn it into a training session. It was agreed that we would like to have Mark Smith give his training session for new people. Jeff Engelsman volunteered to chair the weekend.

July Specialty – Kathy Harmer, standing chairman, not available to give a report. Wanda reported that new member, Tina Church, has volunteered to be in charge of the trophy table and provide a theme.

July Double Bubble weekend – Jeff Parise will chair the weekend activities. Rick Mitchell will run the field events, and Wanda Berner will be in charge of the Lake Inferior Hunt Test seminar.

Hunt Test Sept. 1st , 2003 - Jeff Parise sent the information to Tony Ordonez to give the report. He stated that 52 dogs ran in one day. A profit of \$412.00 was made, but Denny Nowak noted that this is inaccurate as not all the expenses were taken into account. Not all the food was sold, and ribbons, bird deposit, and some postage was not taken into account when figuring the profit. Jeff would like to see the club decide on what type of compensation to give the hunt test judges. more. \$200 was lost on the food concession. \$350 was spent on printing and postage. Discussion regarding whether people not currently competing should still keep getting the premiums as it is costing the club money.

Winter Walking Trial – Teresa Curtis Chairman, Linda Busch Secretary. As there was no time for committee meeting, Linda had gone ahead and secured judges for the trial and set the program for the weekend. Some of the info is into AKC online filing system already. Marshals, Captain of the Guns, and food people are needed.

Field Trial September – Discussion ensued around horse rental and whether or not the club should get involved with the wrangler in renting out horses. Decision was made to give the wrangler the option in the future to decide whether or not she wants to bring horses on her own for renting. Kevin Berta to call the wrangler. It was decided that more birds should be put out early and we would start at 7 am and stop at dark.

**Awards Dinner** – Larry Lykowski gave a report for his wife Cheryl who is the chairman. The Awards Dinner will be held at the Milk Pail in Dundee on January 17<sup>th</sup>. It is the same day as the Wheaton supported entry show. Menu will be the same as last year with Trout, Prime Rib, and Chicken.

**February Hunt Test** – Patty and Dennis Nowak will chair the event.

Futurity Report - Rodney Albin gave information to Tony Ordonez who gave the report. Tony stated Rodney got a few more entries, but there are currently only six pups nominated for 2004, and five litters have been nominated for 2005 with only one pup re-nominated so far. Discussion ensured regarding whether or not to keep running the Futurity as it may start costing the club money to have it. Trophies are extremely expensive and it doesn't make sense to keep having it if we run in the red and the VCOI has to foot the bill. Decision was made to go ahead and have it in 2004 and decide after that what to do for 2005. Several people mentioned they had dogs that could be entered, so there is a possibility of an increase in entries for 2004.

**Spring field trial** – Albin and Ordonez are Secretary and Chairman. Tony stated they have two judges confirmed and one is going to call back, but he needs one more.

Field Trial Clubs of Illinois – Greg Hedien reported he doesn't know what has happened with the fence they were wanting help putting up.

**VCOI Calendar** – Wanda reported work is progressing on the calendar for next year. Cathy Gallagher is in charge of sales.

**Pet Show** – Tim Dyer has arranged for the VCOI booth to be next to his obedience club's booth and we can split the fee for electricity.

**Sports Show** – It was stated the show is believed to have shifted from the Rosemont Convention Center to McCormick Place in Chicago. Jeff Englesman volunteered to be in charge for the VCOI.

It was noted that we should check with Carnegie to make sure we have enough birds available if we are going to have a field event at site M. Currently the alternate field trial slated for site M is at a standstill. The Minnesota Club was not interested in using one of their dates with the VCOI doing the work. Jeff Engelsman volunteered to help Carl Wilbur with activities for that site.

#### New Business -

Wanda Berner reported that Cheryl Peterson is in charge of trophies for the Nationals to be held in Texas in 2004 and would like the club to sponsor a trophy. Discussion ensued. A motion was made to donate to the event, but not seconded. It was decided not to donate to the national trophy fund until they start providing better trophies for the field events. Second, third, and fourth place field dogs are getting the same thing as some of the show classifications that do not hold the same significance.

New member Jennifer Maw was introduced to the group.

Wanda stated that Michel needs new articles for the Bulletin and articles on events before and after they happen. Tom Rowan volunteered to write something after the field trial. Jim Busch was bumped to get his "quote of the month" back in the bulletin. Wanda also noted that she and Michel need dates for events for the 2004 calendar. Linda volunteered to contact K. Harmer and get the specialty date.

#### BREED CLUB DO'S AND DON'TS

Has this happened to you? Someone tells you, "I've been waiting for weeks to hear from 'so and so' from your club..." (about getting a puppy, adopting a rescue, helping with the upcoming show, or whatever). What do you answer? Do you say, "Oh, we've had a terrible time with 'so and so'- she never does anything she's expected to do"?

Wouldn't it be useful if, instead of criticizing, we encouraged each other to check directly with the person involved? Wouldn't it be helpful to call the person yourself and ask if there is anything you can do to help? Tensions in our clubs are exacerbated each time we criticize. Each club is helped by its members who help each other and communicate.

Often it may seem that your clubs breeder-members who show their dogs are indifferent to the people whose dogs are not as "pretty." On the other hand, it may seem that the club's pet owners are more active in activities than its breeder-members, perhaps because the club has an active rescue program.

These are not two different clubs but two different activities of the same club, both of which are very important to our breed. If the pet owners remain interested and active, they may become educated customers of the breeder-members. They may eventually have entries in specialties and all-breed shows. Meanwhile, these pet owners love our breed and are often willing workers at our specialty shows, and they must be appreciated.

With the complications of club dynamics in mind, I hereby offer the following do's and don'ts for dog club members.

**Don't complain** unless you have an idea, plan, or approach to the problem that you think will make the situation better.

**Don't accuse** unless you have verified the facts directly with the person involved by seeking an explanation, information, or clarification, and are absolutely sure that the situation warrants admonition and discussion.

**Don't assume** unless you are assuming that your club members are exercising their best judgment at the time and have good reasons for doing or saying what has been reported.

**Do take responsibility.** Each of us is responsible for the success of our clubs. Often the bravest action anyone can take is to say "I'm sorry."

**Do offer solutions.** Speak up with ideas to improve the situations that you don't like, but be realistic about what a volunteer organization can accomplish. Remember that any solution you offer in which you are not involved probably will not succeed.

**Don't give up.** What we are doing, whether it is breed rescue, breeding better dogs, showing our own pride and joy, or educating the public, is very important to our beloved dogs. Always remember that each members of your club loves these dogs as much as you do. We have that bond together.

#### **PREZ SEZ**

I am really excited that we decided at the last meeting to take back our second day in June at the Ottawa grounds. We are going to hold a training day on Saturday and do our hunt test on Sunday. I am working on getting a speaker to do an hour or two of field training demos with dogs and then we will go to the field and help each person individually with training. The grounds are big enough that we could divide into 3 or 4 groups and work dogs at all levels. My thoughts are that we charge enough to cover expenses of the birds and grounds fee and open it to anyone that wants to attend (even other breeds). We may get some new people that want to start their pups and some people that just want to put their dogs on birds the day before they are in the hunt test.

This training day, added to the Lake Inferior Tyro Classic that we do the Saturday of the double bubble, will again give us field training days for new people. Remember that the other venues that people can do with their dogs already have training clubs set up for them to go to. There are now lots of obedience and agility clubs in the area. We don't need to duplicate what they do. We will be offering the same guidance to our members that want to learn fieldwork. We have members within this club that have bred, trained, and handled some of the top dogs in the country, and a knowledge base that many clubs don't have. We want to draw from this and share our experience with newcomers interested in the field aspect of Vizsla competition.


#### **COVER STORIES NEEDED**

Following Dinner will be our Membership Meeting and the Awards.






If you are planning a breeding, the Prospective Pedigree feature on www.k9info.com is a useful, and easy, tool to combine two known pedigrees. For purposes of fairness, we are going to use two deceased Vizslas.

- Open Internet Explorer and direct to www.k9info.com
- In the search area, type in your prospective sire. In our case, it is DC Rebel Rouser Duke HOF. When his pedigree is shown, click where it says "Click here for printable pdf pedigree"
- Write down the sires ID number, in Duke's case it is: id=vz\_sa358560. This will appear in the title bar as the URL address.
- Go to back to the search screen and select your prospective dam. We are using Brook's Amber Mist. You may have better results without punctuation. Select the correct dog from the results list. In our case it is DC AFC Brook's Amber Mist HOF. Also click to select the printable pdf pedigree.
- You will need to combine the two addresses to make your pedigree. Amber's information from the title bar will look like this:


