

#### MEETING MINUTES

Fall Field Trial Chairman Jim Busch reported that the trial broke even and was a success. Also the fun Trial made money. He suggested a standardized field trial financial report so a more accurate assessment might be made in the future. There was one dog disqualified for lack of a reg. number on the entry form. Jim suggested we read our insurance policy to see what it covers. Roy Greffin said that according to Terry Musser we are covered for everything. Rose Crago suggested that we include this information in the trial book. Harry Ruffner volunteered to check out the insurance policy if given a copy.

Geno Woehrle, National Events Combined Chairman awarded plaques in appreciation for assisting with the Nationals to Lois & Roy Greffin, Cheryl Woehrle, Kathy Harmer, George Peirce, Gwen Tomlinson, Rose Crago, Sue & Randy Boggs, Ann & Tony Lucas, Linda & Jim Busch, and Cris & Tom Gaulke. He said that we had all worked together and pulled it off and deserved a pat on the collective back (VCOI). Many favorable comments have been heard and it is a matter of record that this Nationals had the largest entry for both the field and show events.

Roy called on Ann Lucas as Hunting Test Chairperson to report. Ann said that pending AKC approval a Sanctioned A test is planned for Feb. 21st, (ED. NOTE: THE AKC HAS DENIED OUR REQUEST FOR APPROVAL DUE TO ANOTHER BREED HUNTING TEST WHICH IS ALREADY SCHEDULED IN THIS AREA ON THE 21st.) with Junior, Senior and Master Hunter being offered. It will be on the west grounds at DesPlaines, open to all pointing breeds, with quail and pheasants being used. Judges are Geno Woehrle, Vern Fasse, Jim Busch and Tony Lucas. We will need gunners, bird planters and someone to total points.

The nominating committee for 1988 Officers and Board members is Rose Crago, Ann Lucas and Geno Woehrle.

Lois motioned, Tony seconded to adjourn the meeting. Passed by a voice vote.


