when great dogs are competing for a national championship title, conditioning often determines the victor. A champion must sustain his complete effort to the very end of his performance. The conditioning of a field trial champion differs little from that of any fine shooting dog. It begins while raising the puppy; A puppy should be kept in good growing condition-his bones well covered, yet without excess fat. I prefer to see the rib pattern clearly defined in both puppies and adult dogs. The bones of puppies are soft and will not develope properly if they are carrying excess weight. Adult dogs with broken down feet often mistakenly thought to be congenital or hereditary, are more likely the result of carrying excess weight during the growing time.

Exercise is very important to the growing dog. A puppy receiving sufficient exercise will become collected earlier and develope into a better co-ordinated, more graceful adult dog. The most ideal exercise is actual field work. When exercising a dog never encourage him to run beyond his physical limitations. Some dogs will run with great determination and hunting desire to the point of damaging themselves permanently, Be careful of hot weather. Summer exercise should be done at daybreak while dew is on the ground. Swimming is also good.

Examine your dogs feet for worn or torn pads all during the season, but particularly in the beginning when his pads may be more tender, also check his toenails. It is advisable to keep them short.

Feeding is a major element to proper conditioning. Adding a little steamed bone meal and crude cod liver oil will assure an adequate supply of calcium, phosphorus and vits. A & D. While the dog is being worked strenuously, he should be fed twice a day. Usually the feed manufacturer's instructions are adequate. Canned meats add flavor and animal protein desirable for a working dog. Self feeding for non-working dogs is fine. But be sure they have water at all times.

If your dog is not looking sleek and healthy check the contents of the food you are feeding him. It may not be a quality food. To condition a dog well, you should be able to control his weight at will. To do this the dog must learn to eat properly. He can be trained to eat properly by underfeeding him for 2 or 3 days As his appetite sharpens, gradually increase his feed, but take it away as quickly as he finishes eating. If he stops eating for any reason take the remaining food away. He will soon learn to quickly eat all food you give him. Never over-feed him or leave any food in his kennel while he is being hand fad. After he has learned these eating habits you can control his weight at will by either increasing or decreasing his intake.

Table scraps are fine to use with commercial food. Bones are of little value and can on occasion create serious trouble. As for cleaning his teeth you can do a much better job with a tooth scraper.

Comfortable housing is another important element to proper conditioning. A dry warm sleeping compartment with soft dry bedding is essential. Certainly a dog cannot put forth his best effort when heis spending energy 24 hrs. a day on parasites, kennel sores bruised muscles, eold and dampness. In general, try to keep your dog healthy, comfortable and happy and he will reward you in the quality of his performance.


