At the time Tuffy came into our lives, I was looking for a NSTRA dog (National-Shoot-to-Retrieve-Association). I need a fast dog with a good nose. I already had 2 NSTRA Champions and knew that what I needed would be a hard find. To complicate this, my wife Debbie has become interested in conformation. She was insistent that the dog be show quality. What to do???? A call to Jim Busch was definitely in order.

We had purchased Onpoint's Secret "Radar" FD from Jim several years earlier so he knew what we were after. Fortunately, a litter was coming up out of his stud dog Raany. Jim recommended that we take his pick pup from it. So, off to Vermont we went.

It didn't take long for Tuffy to show us that she was made of "Tuff Stuff". At 4 months she was running and keeping pretty much up with our other adults. She was like a little hunting machine. I shot her first Grouse in Quebec at only 41/2 months of age. With my hunting trip to Kansas rapidly approaching and I thought "why not" bring the little "Tuff Stuff". I've seen a lot of dogs and would never do this normally but this one was definitely different.

SECRETARY REPORT

MINUTES JULY 12, 2003:

After a sumptuous grilled steak dinner provided free from the VCOI club, the meeting was called to order by Wanda Berner, President, July 12th at 8:30 p.m. at the Busch Farm. Approximately 55 people were in attendance. The President gave a short report stating the Board of Directors had met in June following the June Hunt Test at Ottawa, WI. The Secretary did not have her minutes from the last meeting handy, so no report was given. The Treasurer reported a favorable bank account and that the officers insurance was paid.

Patty Nowak, Hunt Test Supernumerary: Patty remarked the June Hunt Test was great. Weather cooperated, they ran 41 dogs, passed many dogs, and profit was \$307.87.

Show/Specialty Supernumerary: Kathy Harmer stated the nine month old female who won the five point major, finished, which put her in the BOB ring which she also won. She then went on to win a Group 1 and Best in Show. Winner was not a club member. Discussion ensued regarding the late show time of 12:30 and how unhappy we were with the arrangement this vear. Also members want a ring with at least two sides to view the dogs. Kathy needs to submit two or three names of judges for next year's show. VCOI Secretary to write letter to Kishwaukee Kennel Club reiterating the problems with this year's scheduled show time and ringside viewing problems.

There was a brief interruption as Jim Busch passed out old ribbons and trophies unclaimed from year before.

Fun Day Activities - Christine Quaid gave a brief report on some of the activities scheduled for the Fun Day Sunday. She said there would also be a CGC test, Therapy Dog Test, and Katie Curtis would be the "child wrangler." Hunt Test Labor Day - Jeff Parise said we need to "talk up" the hunt test as it is the first one of the season. He needs help with bird planting, line judge, help with concession, he has gunners. AKC will allow us to use two judges to save expense money. Hunt Test is on the east grounds.

Fall Field Trial - Rob Tomczak Secretary and Mark Vitkauskas Chairman. Neither were at the meeting, but President Wanda stated she had been in contact with Rob and everything is flowing along and it should be a good trial.

Winter Walking Trial - Linda Busch volunteered to Secretary and Teresa Curtis will be Chairman.

Jeff agreed to deposit them.

Wanda mentioned that Sunday, July 20th is a work day at

Ottawa field trial grounds. Anyone who is available should come and help.

Field Trial Clubs of Illinois -Mark Johnson gave a brief talk about the competitiveness of Vizslas with other continental pointing breeds. He also stated we may want to look into having our own separate award, similar to what some of the other breeds do, for the awards banquet held in Springfield each year. Members agreed to consider it. He also mentioned the other breeds think we need a more equitable solution to the fact we don't open our trials to them.

Gina Ordonez volunteered to handle the calendar photo contest at the Fun Day and Cathy Cook will handle future sales of the calendar. It was stated that putting other Vizsla club event dates on our calendar helps to make it so successful.

Miscellaneous: Wanda stated Carl Wilbur is Supernumerary for Site M and club is still deciding what type of event we want to hold there next March. Carl was not in attendance at the meeting. VCA has ruled to collect more money per dog for events. We believe the amount is equal to \$2.00 per dog now. Specialty Committee - Kathy Engelsman agreed to work on the luncheon for next year. Mark Johnson said there will be a future work party at Joliet to put up/take down fence on Blodgett Road. He didn't know exactly when, maybe August, Tell Mark Johnson or Greg Hedien if you are willing to volunteer. Fence will need putting up in fall, down in hunting season, and then up and down again in the spring. Total of four times a year.



COVER (CONTINUED)

On the day of Tuffy's first birthday, she completed her CKC Field Dog (FD) title, which is very similar to the AKC's SH. Her test scores were very high and placed her on the CKC's all breed Top Ten Field Dog list for 1999. Tuffy also passed the Temperament Testing Association's Temperament Test (TT) at 12 months where she was known as the little, happy, bouncing dog. In the ring, she also sailed through her CKC Championship with her typical ease. Now, I thought that I could have my NSTRA dog back with all of this stuff done.

I didn't even think about getting involved in AKC field trials with Tuffy until Jim Busch asked me to run his Raany, who I had been training, in the VCM trial in April of 2001. With Tuffy away being bred, I only had 1 week to break her for this trial but I thought that I might as well try since MI is a long way to drive to run 1 dog. Tuffy came home with 2nd place in OGD. Not a bad start.

In May 2001, Tuffy completed 2 legs towards her AKC Senior Hunter title at the GSP Hunt test in NY, receiving the Highest qualifying scores both days. She earned her third leg on May 26 with another highest score.

The rest as they say is history, 10 weeks after having her pups. Tuffy was back trialing. 3 point in OGD at the CWVC trial, 4 pts in OGD at Conestoga and the list went on as she rapidly finished her AKC Field Championship.

In March 2002, Tuffy won the NVA's National Championship.

In the summer of 2002, "we" (read: Debbie) decided that Tuffy must now get her Am. Championship since a CKC CH and an AKC CH doesn't make a Dual. Given only a few weeks in the summer of 2002 and 2003, our handlers Tina McDonnell of NC and Bob Double of PA did a great job. Tina sent Tuffy home late July 2002 with 11 points and 1 majour. In July of this year, Bob was able to get Tuffy's final majour and finish her Championship not one week later than Tuffy's son CH Onpoint's Tuff Too Beat TT "Eddie" was able to finish his.

We'd like to thank Jim & Linda Busch that have both been so helpful and encourage along this ride. We've met some great people through the Vizslas and look forward to seeing everyone this spring. Happy trialing.





You know the bones that claim to be able to stand up to the toughest chewers for months? Yeah, well, these guys can do it in minutes.

Planet Pet Goodie Bone and Planet Pet Goodie Ship both pass with flying colors. Travis, Mace and Max all have the XTreme versions (black), while Jes and Riley have the red version for large breeds.

The fact that both the red and black hold up to these dogs is a testament to their construction. Not only have they held up with no sign of wear, but they have held up in some cases for a few years. These chew toys give "Kong" a run for their money.

Like the Kong, there are spots to stuff treats or peanut butter to provide extra entertainment for the dog. Depending on the treat used, it can provide well over 30 minutes of concentrated chewing enjoyment.



The Planet Pet line is available at most pet supply chains and is also easily found online through most pet food distributors. The price ranges from \$8-15, so price comparison is recommended.



Quick -N- Easy Quail Bake

12 dressed quail
12 strips bacon
1 large onion, sliced
1 can cream of mushroom soup
1/2 garlic clove, chopped
1/2 t. salt
1/2 t. pepper

Wrap each quail with a strip of bacon. Sear in hot, oiled skillet until bacon is done. Set aside. Combine the cream of mushroom soup, chopped garlic clove, salt and pepper. Spread the mixture in the bottom of the baking dish. Place the seared quail, breast up, in the baking dish and cover them with the sliced onion. Cover and bake at 350° until tender (about one hour). Excellent served over a bed of white or wild rice! Serves 6.


