Lunch & Judges Dinner

Information regarding meals will be distributed when the running order is sent out.

Parking/Camping

Camping is allowed on the grounds, but there are NO SERVICES and units must be self-contained. A \$10 camping fee will be due and payable for each night to the IDNR. Pit toilets are on the grounds.

Per IL DNR, all rigs must be parked perpendicular to the grass areas.

Wrangler

Handler horses/wrangler will <u>not</u> be provided.

Horse Owners

Everyone with horses is required to clean-up after them and place manure on the designated area located next to the barn

Those on grass areas need to scatter hay/straw refuse in the grass adjacent to them.

ANYONE with horses on the paved parking area must remove ALL hay, straw and manure from the pavement, prior to departure each day as required by the DNR and our agreement with them.

Water will be available onsite along with tubs.
